## 500 Gather to Support Opposition Of Council to Bresler's Appointment

At one of Greenbelt's largest public meetings in recent years, almost 500 citizens heard the City Council pass a resolution on Jan. 30 asking Governor Spiro T. Agnew to "reconsider and rescind" his recent appointment of Charles Bresler as State Coordinator for Federal Programs and liaison representative for Montgomery and Prince Georges Counties. Bresler, a Republican running-mate of Agnew's, made an unsuccessful bid for the post of State Comptroller last November.

A standing vote taken early in the evening showed that the entire audience favored the proposed resolution, with a single exception; and the lone dissenter had changed his vote by the end of the meeting.

The council's resolution, introduced by Councilman Francis W. White, and passed 4-0, described Bresler, a developer with large land holdings in Greenbelt, as "a man who has conclusively shown an utter disregard for the public interest of this municipality and may therefore potentially subject other areas of the state to the same breach of faith which this municipality has experienced."

The resolution cited as evidence of this breach of faith "his unilateral repudiation of a solemn promise to limit development density, his documented agreement to convey land to the city and upon which he has now reneged, . . . and the many public promises that are contrary to his private acts including what appears to be a reckless denuding of approximately 8 acres of land adjacent to a major entrance to the City . . ."

### Statements by Organizations

Speaking on behalf of Greenbelt Homes, Inc. (GHI), Royal Breashears, the GHI manager, read a 5-page statement outlining Bresler's dealings with Greenbelt since 1961. He concluded:

"Mr. Mayor; Mr. Bresler could have lived up to the covenants — he did not!

" . . . Mr. Bresler could have donated the 3.3 acres for parkland as he promised — he did not!

" . . . Mr. Bresler could have provided land for a high school on a site acceptable to the citizens of Greenbelt — he did not!

" . . . Mr. Bresler could have preserved Parcel 7 as a part of the scenic entrance to Greenbelt — he did not!

" . . . In short, Mr. Mayor, Mr. Bresler could have been a good neighbor. He chose not to be.

"Mr. Mayor, basing our views solely on the record of Mr. Bresler's relations with this community over an extended period — his lack of a due regard for the public concern and the conflicts between his public and private interests — we believe him to be not qualified to serve this city, the bi-county area and the state in the positions for which he has been nominated."

Many of the same points were made by representatives of the Citizens for a Planned Greenbelt (CFPG) and the Boxwood Civic Association.

### CFPG Statement

Mrs. Ed Ross, reading a statement for CFPG (650 members), declared that Bresler "has left a trail of broken promises and has shown a blatant disregard of his word when it conflicts with his private interest. . . . There is nothing in Mr. Bresler's record in Greenbelt," she said, "that indicates he can rise above this conflict of interest." She noted that "even now, at a moment when he is expected in his new position to

represent the best interest of the suburban communities in making most effective use of federal grants, he is fighting tooth and nail to thwart the city of Greenbelt's Open-Space program."

She referred to Bresler's suit challenging the city's need for additional parkland after the city council and the citizens had voted overwhelmingly for a bond issue to purchase the land and the Federal government had given its approval in the form of a \$167,575 open-space grant.

Hugh McEvoy, president of the Boxwood Civic Association (200 families), said, "We consider Mr. Bresler's activities as a land developer constitute such a conflict of interest as would preclude the necessary objectivity to properly

## NEWS REVIEW SUIT POSTPONED

At the request of Charles Bresler's attorney, the hearing on the News Review libel suit scheduled for Jan. 26 was postponed until the latter half of February. Bresler is seeking a court decision on whether the documents requested by the newspaper for its defense are relevant to the issues in the case.

## Monday Meeting Gets Full Press Coverage

Reporters from four metropolitan newspapers were represented at the press desk covering last Monday's meeting protesting the Bresler appointment. Excerpts from their eye-witness accounts of the proceedings follow:

### The Baltimore Sun

(Greenbelt Demands Agnew Remove Bresler From Post)

"A series of speakers from the audience, some of them reading for over twenty minutes from mimeographed texts, attacked Mr. Bresler for not cooperating in keeping Greenbelt green. . . .

"Listed among Mr. Bresler's alleged transgressions were:

1. That he promised the city that he would build only low-density housing units in a 50-acre lot in Charlestowne Village and is now building high-rise apartments on the lot.

2. That he promised to give 3.3 acres of park land to the city in 1964 and later reneged.

3. That he razed a scenic wooded lot near the entrance to the city for 'vindictive reasons.'

4. That he is fighting to keep the city from acquiring 18 acres of park land near Greenbelt Lake.

5. That he is a 'bully' for lodging a \$2,000,000 libel suit against the Greenbelt News Review, a non-profit weekly run by volunteers."

### The Washington Evening Star

(Cancel Bresler Appointment, Greenbelt Unit Asks Agnew)

"The city . . . received assurances from Prince Georges County Democratic State Senators Edward T. Conroy and Meyer M. Emanuel, Jr., that they would meet with Agnew shortly to discuss Greenbelt's vehement opposition to the appointment. Conroy and Emanuel attended last night's meeting.

"Mayor Edgar L. Smith said after the meeting that he also would seek an appointment with Agnew to explain the city's position and to point out that Bresler would be ineffective as a liaison with Greenbelt because of mutual antagonism that exists. . . .

"The vote (on the resolution) followed strongly worded speeches by 15 witnesses who denounced Bresler for allegedly breaking promises to the city and for the conflict of interest they said he would have in the new job because of his land development business. . . .

"Because Bresler was named to a position on Agnew's personal staff, the appointment does not require Senate confirmation. . . .

"Almost all of the speakers last night noted that Agnew overwhelmingly carried Greenbelt last November, but that Bresler was soundly rejected."

### The Washington Post

(Bresler Appointment Rapped in Greenbelt)

"The crowd that packed the auditorium of the Greenbelt Center School applauded the dozen speakers who condemned Bresler's appointment. Bresler was absent, having cited previous commitments at the General Assembly in Annapolis.

"Bresler, a land developer, was accused by the speakers of reneging on a promise to donate land for park use and to permit only low density development of land he owns near the proposed school site."

### The Washington Daily News

(Anti-Bresler Meeting; Throng Raps Agnew's Man)

"Speaker after speaker denounced Mr. Bresler's dealings with Greenbelt and called on the Governor to immediately fire him.

"At the end of the meeting, the chairman of the town zoning committee, Edward Wuermser, the only person to vote against asking the Governor to fire Mr. Bresler walked to the microphone and said he had changed his mind: ' . . . I am zoning chairman and Republican precinct chairman in this town. Too many things can be made of it,' he said.

"He said Greenbelt and its Master Plan are the most important issues and he wanted to be with his neighbors."

The Master of Ceremonies was Joe Pachtler, Sr. Instructor of the Maryland University Fire Extension Service, who, despite being a "neophyte", did an excellent job. Guest Speaker for the evening was Robert "Skip" Smith, Fire Marshall of Montgomery County, whose comparison of the Fire Services debt to the community and the debts of homeowners to their mortgage-holders, was extremely interesting and thought-provoking.

The Chiefs Award for 'The Most Valuable Member of the Year' went to Richard "Dick" Bragonje, Lieutenant of the Rescue Squad. Top honors for the most ambulance and fire calls went to Kenneth Stair, who was top man on the list in both categories.

Member Relations Committee members in charge of the open house are Josephine SeSay, Katherine Keene, Denise Sutton, Mary Ann Baker, Norman Weyel, Betty Allen, and George Phibbs. Further details will follow.

### Increase Membership Fees

The GHI board voted on January 27 to raise the membership fee for new members from \$125 to \$150. (The registration fee of \$5 is unchanged.) The \$25 increase will go into effect for all houses listed for sale after 8 a.m. Friday, Jan. 28. The increase, which will yield \$5,000 a year, was necessary because the present fee was not covering expenses.

The board also adopted a series of measures concerning the new homes. It voted not to apply a 3% working capital assessment. Several reasons were given for this decision: (1) Unlike the situation with respect to the original GHI homes, the yield from the 3% assessment is not needed; (2) The purchasers of the new homes will be making very large down payments; (3) The new homes will only be sold or resold to current GHI members so no purpose will be served by the 3 percent assessment; and (4) purchasers of the new houses can only sell their homes in a controlled market—increases in equity will be shared with the corporation in a predetermined ratio, based on the appraised value.

Audit committee member Seymour Kaplan suggested that this was the time for the corporation to reexamine its policy of permitting unlimited resale prices. He thought the corporation should consider the practice followed by some other co-ops of allowing a departing member to receive back only what he paid in, plus improvements.

### Woodland Hills Request

Jim Cassels and Jack Maffay of Woodland Hills requested the board to consider granting an easement for a 4-foot pathway along the property line of the new GHI home lots on Northway. Such a pathway, they said, is desirable for access to the playfield between the Woodland Hills and Lakewood projects behind the 13 court of Hillside. The GHI board took the matter under advisement, though there was a general feeling that the request came too late as the design of the new home and its placement on the property had been settled.

A member from the 38 court Ridge complained that new paving on the parking lot had left an excessive amount of unsettled dust and stones. GHI promised to investigate.

### GDC MEETING

Prior to the GHI meeting, a meeting of the Greenbelt Development Corporation Board was held. The board decided to consider a rent increase for the Parkway apartments it operates. The last increase took place Feb. 1, 1965 and the corporation is facing rising costs, including a \$14,000 reroofing and metal work program.

City Notes

Shifts in the weather recently have had the Public Works Dept. alternating between winter and springtime chores. One day they were spreading salt on snow-covered streets. Before the week was out, they were raking leaves away on several of the playground areas. In addition, they laid a surface of bluestone on several muddy stretches of the pathway along Crescent Rd. between Northway and Lastner Lane.

Last Friday's downpour showed up some drainage problem areas. Catch basins at Laurel Hill and Hillside and at 10 Crescent had to be cleared of debris.

The bridge across the storm drainage channel which runs between Lakewood and Woodland Hills at Fayette Place was repaired. Also repaired was playground equipment at various locations, and a cracked concrete sidewalk on Greenhill Rd.

serve the Greenbelt community as well as the State of Maryland." He specifically mentioned the denuding of parcel 7 which now, "in all its ugliness" mars the entrance to the town.

Citizen Statements

Among the citizens who spoke, Norman Charles, 2-D Gardenway, charged that "Bresler's legal gymnastics make our City Council look impotent." He asked "How can one man do this to us, a large group of people?"

Former councilman Lewis Bernstein, now a resident of Montgomery County, expressed the belief that if the governor were to investigate the Greenbelt situation he would find that Bresler "does not put the public interest above his own private gain." This point was echoed by many speakers throughout the evening.

Another former councilman, Clifford Simonson questioned whether Bresler can recognize the public interest, let alone serve it.

Simonson pointed out that land use has historically been a vital issue in Greenbelt which is "perhaps the most famous planned town in the United States, although we may not be aware of it and the officials certainly don't seem to be aware of it. . . . It is known wherever urban planning is taught."

Officials Present

Elected representatives present included State Senator Meyer Emanuel (chairman of the Prince Georges County delegation), Senator Edward Conroy, Delegates Arthur Dorman and Andrew Mothershead (representing legislative districts encompassing Greenbelt), Mayor William Gullett of College Park also attended.

Mayor Smith told the audience that Del. Mothershead had voiced opposition to Bresler's appointment.

Governor Agnew's office sent a note of regrets but no representative; Charles Bresler was not present, although he had been invited. According to the Baltimore Sun, Mr. Bresler said that he did not want to engage in a "verbal battle with 20 or 30 disgruntled people."

Also among the missing was Greenbelt city councilman David Champion. In answer to an inquiry from the audience, Mayor Smith said he didn't know why Champion wasn't there. Champion

last week opposed holding a hearing on the appointment.

Writing Campaign Urged

Many persons said that they had voted for Agnew, emphasized their belief that the issue was non-partisan, and urged their fellow-citizens to write the governor.

Albert Herling, 13-M Ridge, said that "it bothers me greatly to see the possibilities of a good administration getting off to a wrong start out of perhaps a sense of mistaken loyalty by the governor. . . . I think if he (Bresler) had any consideration and respect for the man with whom he ran for governor. . . . that he would save the governor the embarrassment that this nomination has brought."

Miss Katherine Keene, 6-H Hillside, said that Bresler should not be given a position in Prince Georges or Montgomery County because "there is a conflict of interest."

Mrs. Jackie Shabe, reading a letter to the governor from the First District Independent Democrats, stated: "I submit that Mr. Bresler is 'wrong' and not the entire town."

Other speakers included: Jack

Maffay, president of the Woodway Community Development; Mr. Milton Hoffman, 7-G Research; Mrs. Catherine Foster, 36-J Ridge; Mrs. Rita Fisher, 2-H Gardenway; Mrs. Russell Kifer, Jr., 6-G Hillside; and Mrs. Janet James, 1-D Plateau.

Wuermsler Statement

In a dramatic final incident, Edward Wuermsler, who had earlier cast the sole dissenting vote on the council's proposed resolution, announced that he had changed his mind. Wuermsler is the chairman of Greenbelt's Advisory Planning Board (APB).

After stating that he was Republican precinct chairman in Greenbelt, he referred to the reporters present from the metropolitan press and said: "I won't have the Baltimore papers place my name and position against the city of Greenbelt, so I am changing my vote." He added that he did not want to endanger the Greenbelt Master Plan.

After the meeting he amplified this explanation, saying that if he took a public position in opposition to the large number of Greenbelters present at the meeting he felt he would have to resign his APB chairmanship which he didn't want to do.
