Army Band & Chorus At Lake Park July 18

The U. S. Army Field Band Ceremonial Detachment & The Soldiers of Song will perform at the Greenbelt Lake Park Bandstand on July 18, Thursday at 7:30 p.m.

The Ceremonial Detachment is the newest component of the United States Army Field Band. In its relatively short history, it has proved to be one of the most versatile and entertaining musical organizations performing before the public today.

The Soldiers of Song, an elite section of the "internationally famous" United States Army Field Band, was organized in January 1965. In presenting their programs, the Soldiers of Song adeptly combine military bearing with a high degree of showmanship. In addition to special renditions of well-known compositions, they add color and variety to their shows by featuring specialty acts. These include The Folksingers, a popular folksong duo, The Troubadors, a quartet that has mastered many styles of music, and The Hayseeds, a country and western group headed by former Grand Ole Opry singer, Jim Tarleton.

City Notes

Judging from the size of the traffic jam after the Fourth of July fireworks display, the largest crowd ever came out to witness the event. About 300 additional cars were able to be parked in two recently filled areas behind the dam. From there it was an easy walk to the shoreline opposite the fireworks; but good fortune turned to bad when it came time to leave. Many vehicles were locked in for nearly an hour before they were able to get away.

The city reports that the crowd was in general orderly. To prevent the careless tossing of fireworks among the crowd, several plainclothes policemen were on duty, mingling among the spectators. They reported less than usual of this sort of activity.

Newly in bloom for the Fourth was a new species of water lily recently set out in the lake near the peninsula. Acquired from an anonymous source, these lilies have a smaller than usual leaf and red flowers. They are a hardy type, able to survive the winters in this climate.

The Public Works crew has done a good deal of tidying up in the Lake Park area. They removed two truckloads of trash and debris from the lake itself. They also shored up the waterline of the lake near the concession stand, using dead trees to make a firmer shore line and backfilling to build up the shore. This procedure follows advice on erosion control given the city this spring.

Council Debates Beer at Lake, Castigates Magazine Article

A lively discussion last Monday night on the rights of beerdrinkers provided a welcome relief to a city council agenda filled with news of plans for commercial and industrial development of vacant land, of revised plans for a perimeter road and schools, of a controversial magazine article, and of pending legal cases.

A motion to permit consumption of beer at the Greenbelt Lake was left on the table after sponsor Bill Hoff was unable to convince a majority of councilmen that the present situation was inequitable. The present ordinance permits beer drinking only by groups with permits. This, councilmen Hoff and Gerald Gough felt, was unfair to individuals and families.

They wanted to know what constitutes a group and posed the hypothetical question whether a "Hoff-Gough March and Chowder Society" could get a permit. City Manager Giese was non-committal, though he pointed out that permits are granted in the name of individuals. Spectator Wally Cohen, citing his adverse experience in reserving space at the lake for a Cub Scout picnic, did not seem impressed with the news that the permit would allow beer drinking, when it was reserved space he wanted. Giese said that space is now being reserved for Greenbelt groups.

Concern was expressed that the motion would encourage public beer drinking by juveniles. It was noted that State law already prohibits this, but Marge Bergemann asked how about drinking by "juveniles over 21." Concern about debris was expressed by Seymour Kaplan, who earlier had asked for an ordinance to clamp down on drinking from open bottles in the Center Mall because of the danger from broken glass left on the ground.

Commercial Plans

The council expressed concern over reports of plans for commercial development of the Jaeger tract — the land on Kenilworth Ave. abutting into the Greenbelt Regional Park. A petition is pending for the rezoning of approximately 16 acres from the R-H (High-rise apartments) zone to the C-2 (General Commercial) zone. The APB met with one of the owners, B. F. Saul, II, and was advised that the plan is to construct 15 high-rise office buildings with penthouses on the property.

Saul also indicated that there was a tentative agreement with the National Parks Service for the exchange of land in which the Parks Service would gain the portions of the Jaeger tract that extend farthest into the Greenbelt Regional Park in exchange for giving up a portion of the park fronting on Kenilworth Ave. and extending up to Greenbelt Road. Saul indicated, according to the city, that a condition for this exchange of land would be his obtaining commercial zoning for the intersection of Greenbelt Road and Kenilworth Ave.

Recommendations are expected shortly from the APB.

The council received a subdivision plat for development of the 80-acre industrial tract near the B&O railroad tracks, owned by some of the developers of the Springhill Lake Apartments. The Technical Staff of Maryland National Capital Park and Planning Commission has expressed concern over the fact that the only access road shown is Cherrywood Drive. The council voted to support the Technical Staff in its efforts to assure adequate road access to the property.

Perimeter Road

The council was asked to react to the possibility that the three schools on parcel 2 — land between the GHI property and the Baltimore-Washington Parkway — might be rearranged so as to permit a perimeter road to be built along the easterly portion that would satisfy the city.

According to Giese, one possibility being considered by the technical staff of the county board of education is the location of the junior high and elementary schools on land north of Northway Road on parcel 1, leaving only the senior high school on the land (parcel 2) currently owned by the school board. Under the original plan, all

three schools were to be located on the 60-acre tract on parcel 2.

The council has scheduled a special meeting with the APB on this matter for Monday, July 15.

Article Upsets Council

Councilmen and members of the audience expressed their indignation at a story on Greenbelt that appeared in the July issue of the magazine *Washingtonian*. On a motion by councilman Francis White, who said the article was "poorly presented, full of inaccuracies, and did not do justice to the city," the council unanimously voted to send a letter to the editor of the magazine correcting the errors and presenting Greenbelt's side of the story.

Mayor Edgar Smith said he and other city officials were interviewed, yet the reporter chose to ignore their remarks and to give prominence to those of developer Charles Bresler, whose critical remarks about Greenbelt were freely quoted in the article. Smith says he can draw no other conclusion than that the article was slanted and that the reporter "used the information in the way he wanted." White pointed out that nowhere in the article was mention made of the efforts the city made to preserve its original character by developing and adopting a Greenbelt Master Plan and by spending thousands of dollars to acquire parkland.

Councilman Gerald Gough said he was disturbed that the article used pictures of apartments, rather than GHI owner-occupied homes, to characterize Greenbelt. He was also concerned that the article left the impression that the city council did not oppose vigorously the high-rise apartments and violation of covenants on the Charlestowne tract.

Hugh Jascourt from the floor said that the article missed the significance of the financial support given by the citizens to assist the *News Review's* appeal of a \$17,500 libel judgement awarded Bresler. This citizen support, he said, was a reflection of concern over the legal issue involved of what a newspaper can report — an issue, which the *Washingtonian*, of all groups, should have recognized.

Gun Controls

Mayor Smith announced that the city has received from the Council of Governments a model gun control ordinance. It will be placed on the agenda of the next council meeting for consideration. At the Ocean City convention of the Maryland Municipal League, a motion calling on all municipalities to support such legislation was introduced by Smith; after a close fight, a motion to table the resolution was defeated 27 to 23. Then the resolution passed easily.

Law Cases

The council was advised by city solicitor Emmett Nanna that the hearing on the city's case seeking conveyance of 3.3 acres of the Charlestowne tract as promised by Charles and Fleur Bresler will be held on July 30-31 at Upper Marlboro. This will be followed on August 1 by a hearing on the city's case seeking injunctive relief against the construction of 21 additional apartment units on the Charlestowne tract. Served with papers in the latter case were the Breslers, Burton Reiner, a partner, and Philip Freedman, treasurer of Stones, Inc., to whom the land was sold after a building permit had been taken out by the Breslers.

GHI Assessed

Council was notified that the cost assessable to Greenbelt Homes, Inc., for construction of the Greenhill Rd. cut-through to Hillside Rd. came to \$5,104. Giese said that the cost was lower than originally calculated. Council approved the assessment unanimously.

In another action concerning GHI, the council approved the subdivision plan for the 25 townhouses. See COUNCIL p. 2, col. 1

to be constructed opposite the North End School. However, in accordance with the recommendations of the APB, the council stipulated that GHI construct a sidewalk along the public right-of-way between Research Rd. and Laurel Hill Rd. Present GHI plans call for the sidewalk to run alongside the townhouses on GHI property. Another recommendation of the APB that GHI should provide for extension of the internal walkway system south through the middle of the block to Hillside Rd. was considered premature by the council since the internal walkway has not been extended to Hillside yet.

New "Sports Center"
Giese reported that the old bowling alley area below the Coop Supermarket is scheduled to open under private management as the Greenbelt Sports Center in August. Facilities will include 10 automatic archery units, snack bar, billiard tables, 6 Ten Pin automatic alleys, and some pinball machines.

Other Action
The council accepted portions of Springhill Lake and Breezewood Drive into the city road system but tabled a motion to accept a 100-foot section of Gentry Drive at Greenbelt Road. Concern was

expressed that this action was serving the purpose of First National Realty rather than Springhill Lake residents. The council wanted more information on the implications of this action.

After a successful trial period of 30 days, council made permanent the closing of the roadway connecting the Center School parking lot and the West Center parking lot behind the Municipal Building. Barricades placed across the street permitted the creation of 5 additional parking spaces, 2 of which are reserved for official vehicles.

Council approved expenditure of \$1,475 for purchase of radar equipment and \$4,285 for a new air compressor. Also approved was purchase of two gas lights for the ornamental entrance to Boxwood Village at a cost of about \$140.

Council heard an appeal from the sponsors of the Little League and Boy's Club for additional maintenance work on the baseball diamonds. Giese said that such aid would be forthcoming now that additional summer aid is available.

John Churchill was reappointed to the Parks and Recreation Advisory Board. He had been temporarily out of town.

Dividends

As of July 1 the regular quarterly dividend was added to member's accounts at the rate of 5% per year. Over \$36,000 has been paid during the first half of 1968. Dividends are calculated on multiples of \$10, on the lowest amount in your account between the 15th and the last day of each month. No dividend is paid if you let your account go below \$10 during the quarter and no dividends are paid to borrowers if their shares go below \$100.

SUMMER BONUS

Twin Pines will add one cent for each ten dollars deposited in your account beginning 15 July 1968. All deposits made on or before 15 July will earn interest from the 1st of the month on total amounts of \$10 or more.

NEW MACHINE

Twin Pines has improved its service to members by buying a new machine with which to produce more readable copies of your quarterly statements. The machine is also available for copying service at 10c, 3 for 25c and unlike our old machine, will reproduce any color in black and white.

This should serve as a reminder of the many services that are available at your cooperative savings and loan association. We have money orders - up to \$250 for 15c, notary public service from 9 to 9 (9 to 5 Saturday), Greenbelt maps at 10c, checks cashed for members only, and wholesale life insurance available to members at remarkably low rates. Consumer Reports are available in our office - or you may order them for home delivery at \$4 per year (instead of the regular \$6 individual rate). And, of course, you can leave your News-Review articles or ads here, and find a copy when yours blows away.

Total income for the second quarter of 1968 was \$52,148; total expenses were \$13,108; leaving net operating income of \$39,040, of which \$18,573 was paid to members as dividends at the current rate of 5% per annum.

Total assets and liabilities of Twin Pines now total \$1,709,007 an increase over one year ago of over \$290,000. Loans to members now total \$1,696,667 while share savings now total \$1,573,274.

The demand for loans is so great that Twin Pines has had to borrow \$50,000 from the bank. We would rather pay our members in dividends - at the highest rate available in the area - so a summer bonus of 1/10th of 1% will begin on Monday, 15 July.

The summer bonus has become a popular feature over the last few years. For each \$10 deposited in any account one cent is added by the association up to a maximum of \$2.50.

Loans Committee

Members might be interested in a report of one of the hardest working volunteer committees they have ever heard: the Loan Committee of Twin Pines. It meets each Thursday night to make appraisals and to consider all loan applications. In the five months ending May 30 the committee had met 22 times, they had appraised 119 GHI homes, and processed 100 loans, and the busiest season hadn't even started!

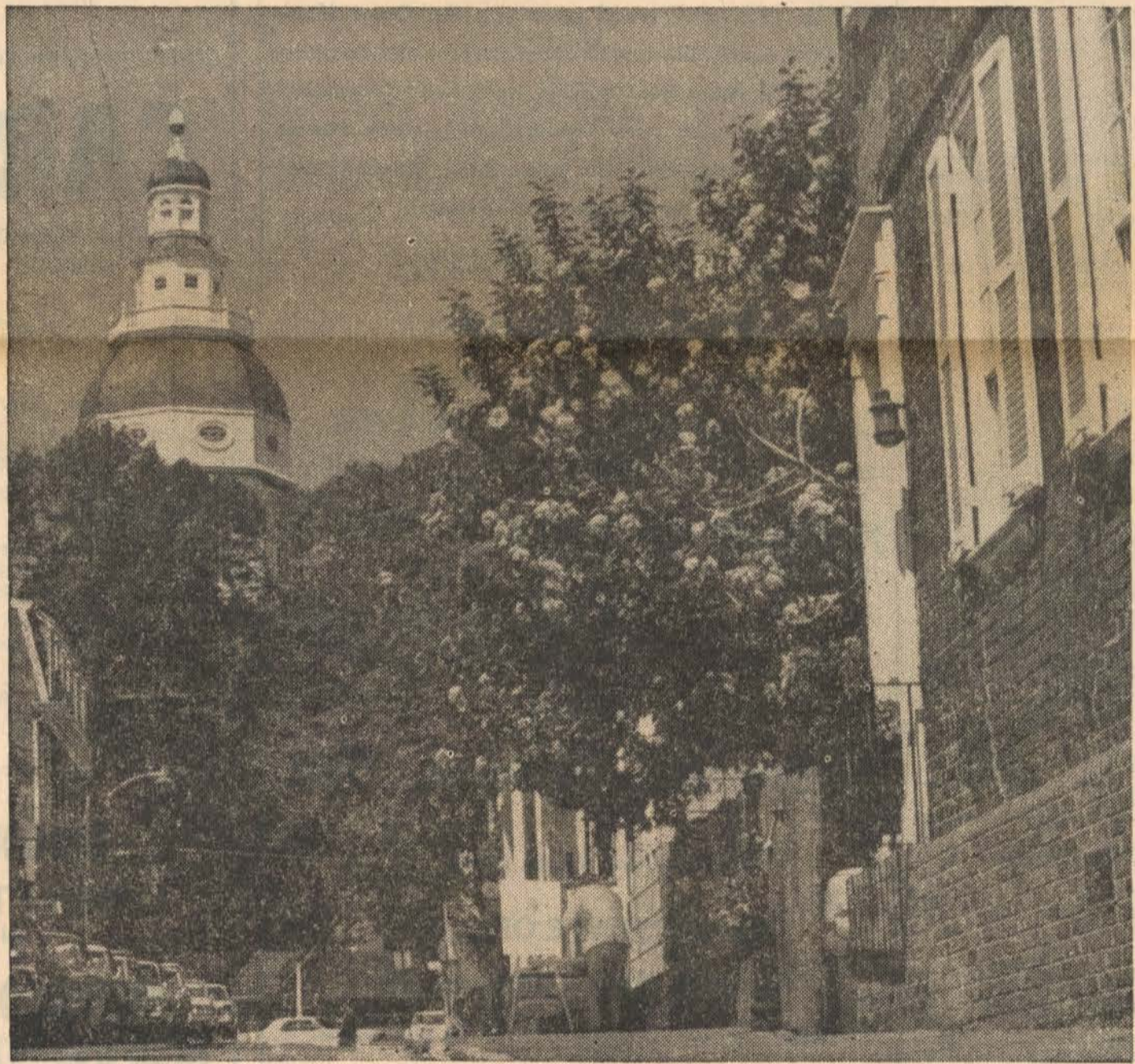
