TEN CANDIDATES FILE FOR FIVE CITY COUNCIL SEATS

A total of ten candidates will compete for the five vacancies on the city council in the election on Tuesday, September 16. The latest candidates to file nominating petitions before the deadline last Monday were: Joel A. Katz, 6221 Springhill Ct.; Elizabeth K. Maffay, 128 Northway; William L. Hoff, 71-E Ridge; Milton Hoffman, 7-G Research; and Edgar L. Smith, 118 Greenhill.

They join the following five candidates who filed earlier: Leo Gerton, Francis W. White, John P. Bogumill, Thomas X White, and Richard R. Pilski.

All five incumbent councilmen — Gerton, White, Pilski, Hoff, and Smith — are running for reelection for the two-year term.

According to city clerk Nita Sacra, there were a total of 2,991 registered voters at the close of registration Monday. Center precinct had 1,012; North End precinct 869; and Springhill Lake precinct 1,110. In 1967, there were 1,904 registered voters.

A list of voters whose names have been removed from the registration list for reason of move-out is published on an inside page of this issue of the News Review. Any person whose name was removed may be reinstated if he certifies to the city clerk that he resides within the city of Greenbelt.

Following are biographies received from the new candidates.

MAFFAY

Elizabeth Maffay, a resident of Greenbelt since 1957, is the wife of John W. (Jack) Maffay, and the mother of five children.

Educated at the University of Munich with a major in languages and a minor in journalism, Mrs. Maffay is at present a housewife. In the past she has found time to put her training into practice as a reporter for the Prince Georges Post and Bel Air Express.

An officer and charter member of Citizens For a Planned Greenbelt, Elizabeth Maffay has long been active in civic affairs. She has served as a Greenbelt Delegate to the P.G. Civic Federation, Petition Co-Chairman for Operation Charter 1968, a Delegate to O.C.D.N. Charter Convention, and a former den mother, pack 746.

Currently she is chairman of Greenbelt's Labor Day Festival Talent Contest, which she has coordinated for the past several years.

She is on the Advisory Board of A.P.T. (Against Poverty Together), an officer in Greenbelt Republican Club, and Chief Judge of Elections precinct 6.

Mrs. Maffay is also a member of St. Hugh's P.T.A., Greenbelt Lion Belles, and P. G. Young Republicans.

KATZ

Joel A. Katz serves on the steering committee of the Citizens for a Planned Greenbelt. He is vice-president of the Friends of the Greenbelt Library, president of the Springhill Lake Democratic Club and a member of the Greenbelt Lion's Club.

Katz was born and grew up in Pittsburgh, Pennsylvania, and has lived in Greenbelt for three years. He has a B.A. degree in Labor-Management Relations from Pennsylvania State University, a Master's Degree in Secondary Education from the University of Pittsburgh and a year towards his doctoral degree in Special Education and Rehabilitation.

Katz is employed at the District of Columbia Children's Center as an Education Officer. He administers a program for juvenile delinquents and the mentally retarded. He also served as Program Director for the Montgomery County Heart Association and is a former artillery officer. He is thirty years old, married and has two children. His wife, Lana, is a former teacher in the Prince Georges County School System.

Katz was awarded a Ford Foundation Teaching Internship and a Department of Health, Education and Welfare fellowship for advanced studies of children with special learning problems.

HOFFMAN

Hoffman has lived in Greenbelt for the past seven years and is retired from the Armed Forces in grade Lieutenant Colonel, after having moved up through the ranks from his enlistment as a private in the latter part of 1939. During the Berlin Airlift he was Accountable Officer for all supplies sent into that beleaguered city; he built a mile-long railroad from scratch along the aircraft docking ramps to expedite traffic into the waiting cargo planes. In those days a Corps of Engineers Officer was a jack-of-all-trades. This was at Rhein/Main, Frankfurt, Germany. He was Command and Staff Materiel Inspector when he retired.

Hoffman is a graduate of the University of Maryland. He took his A.B. in Philosophy and History. He worked as an unpaid volunteer at D.C. Village while still on active duty stationed at Bolling Field. He is an active working member of Drew Pearson-sponsored BIG BROTHERS of the National Capital-P.G. Area.

Hoffman is an amateur experimental gardener: in a 20 sq. ft. area he experiments with corn, tomatoes and pedigreed cucumbers.

Hoffman is a member of the Planning Committee of Greenbelt Homes, Inc., and is presently making an inventory of the structural maintenance of the approximately 1600 homes in GHI. He is also an elected Auditor of the corporation and is making an independent and continuing study of the Maintenance Expense Accounting Systems in the books of the Corporation.

Hoffman has a son and daughter-in-law and two grandchildren

Access Roads to High School Site Dominate GHI Meeting

At its regular board meeting, August 14, the Greenbelt Homes Inc., board of directors voted to meet again with the city council to go over GHI's recommendations for the access roads to the proposed school site. An extension of Hamilton Place or Eastway Road had been suggested at a prior joint City Council-GHI meeting. GHI had asked the city to study the feasibility of these alternate routes and to make recommendations to the school board. GHI further asked that the city attempt to acquire the southernmost part of the school tract (between the proposed perimeter road and GHI property opposite Hamilton Place) and that access to the perimeter road be provided GHI at the northeast corner of the GHI property known as the Administrative Tract.

In deciding to pursue the issue further with the city, the board seemed to have mixed feelings over the Eastway access road. In some respects it was felt development of Eastway would have less impact on GHI property than other access roads, but other problems, such as the terrain, were involved.

Thomas White, chairman of the Audit Committee, felt GHI should put pressure on the school board to provide better access roads, including the perimeter road. He also suggested that GHI pursue a possible tieup with the NASA interchange.

Director Charles Schwan felt it was unrealistic to expect the school board to build such roads. Stating that he was less enamored with the Eastway access than formerly, he nevertheless felt it was absurd for the school to have just one access road, Northway extended.

Capital Improvements

Bids are moving along on the capital improvements program, and some work is underway. GHI is asking Suburban Trust for a 10-year period to pay back the loan rather than the original five years. Manager Roy Breashears stated that the loan could probably be paid back faster after seven years. Negotiations with Suburban Trust are still in the mill.

Though dismayed that more capital improvements work has not yet been done, board members

thought they had been overly optimistic in anticipating that half of the work would be completed in fiscal 1969-70. Director Jim Smith said they should have considered financing and labor difficulties when they first began. It is still hoped that the program will be completed in two years, possibly three years.

Three townhouses have become available, with one of the three probably taken. November 7 is the date the contractor is supposed to have them completed, but rain days, strikes, and other labor problems will undoubtedly extend the period.

Twin Pines Loan

Without too much deliberation, the board approved a short term loan of \$25,000 at 8½% interest to Twin Pines Savings and Loan Association for the purpose of making home loans. In a letter to the board received on the evening of the GHI board meeting, Twin Pines stated that necessity for additional funds arose because of an extraordinary number of sales, 25% over last year's during the same period. The board felt its money was fully protected as it will hold the first and second mortgages on the properties. Also the money will be earning very favorable interest.

However, all of the board members protested the short notice given by Twin Pines to consider the issue. Charles Schwan, in particular, called Twin Pines' attitude "cavalier" and stated that, at the very least, "a warm body should have accompanied the letter", to answer the various questions that were raised. Dave Lange, for instance, wanted management to look into the repayment schedule and also to make sure that Twin Pines would have a large amount of money available when the townhouse purchasers are desiring loans.

Other Business

A member living in a frame house was granted permission for himself and his neighbor to remove the steampipes in their bathrooms and kitchens, providing they have adequate heat in the bathrooms and that they agree to return standard heat to the house when it is sold if the next purchasers so desire. Such an agreement will apply to all future owners of the house.

Sixty dollars was authorized for use in the Labor Day Festival. Fifteen dollars was sent to the Heart Fund in the memory of former board member Joe Cherry, who passed away recently. Douglas Hawes advised the management to redetermine the yard boundaries of a home at 57 Ridge, which is expected to be sold soon. Further discussion will be underway to consider locating a park in a 9-10 acre site between Laurel Hill Road and Plateau Place.

C-2 Zoning Request For Parcel 8 Denied

On Wednesday, August 6, the Maryland National Capital Park and Planning Commission recommended denial of an application for commercial zoning of parcel 8 — the 2.5 acres near Boxwood Village at the Crescent Rd.-Kenilworth Ave. entrance to the city. This was in accordance with the recommendations of its technical staff and of the City of Greenbelt, which is desirous of purchasing the land for parkland. The county commissioners sitting as the District Council will have the final say.

The zoning request by the trustee-owners (John Lewis Kelly and Solomon Grossberg) was filed a year ago and called for a change from RPC (Rural Planned Community) to C-2.

A previous rezoning application on Parcel 8, instituted by previous owners, Crescent Leasing (Michigan, Solomon, and Associates), was denied by the District Council on October 12, 1966, although the Prince Georges Planning Board at that time recommended in favor of C-1 (local commercial) zoning.

Pre-judging for Bike Contest

The Greenbelt Lion's Club will again run the decorated Bike Contest in the Labor Day Parade under the chairmanship of 1st Vice President, Henry Fisher. This will be Fisher's sixth year with the youngsters.

The new method will be that the kiddies will line up at the usual place at Ridge and Gardenway before parade time and three officers of the Lion's club will then judge the Best Decorated Bikes and hand their choices to Chairman Fisher who will keep the kiddies in suspense until the Labor Day Festival announces all their awards. It is advisable that parents get the children down to Ridge and Gardenway at or before 9 a.m. so that they will be judged for the five trophies. The age limit will be 12 years of age, but this shouldn't stop the older ones from lining up and getting into the parade, says chairman Fisher. Age groups and awards will be as follows:

to 4 years of age, one trophy; 5-7 years, one trophy; 8-10 years, one trophy; 10-12 years, one trophy; Group Award, one trophy only. All bikes must be decorated. This includes wagons and trikes.

Firearm Control

To the Editor:
If we are not to deny our Judeo-Christian heritage we must bear witness to it - sometimes in silence, but so often in vocal assent or dissent - whatever the case may be.

The question in point: firearms control.

We are told: "Thou shall not kill." What does it mean for me - just that. Leo Gerton, at last week's council meeting, told of two cases involving local citizens and firearms. I shall cite two others to reinforce what Mr. Gerton had to say and what I would like to reiterate.

About ten years ago there lived in town, a District police officer and his family. He was required to keep his weapon in his home even when off duty. No one knows what really happened, but the upshot of the incident was that he and his wife grappled with his service revolver; it went off; his wife was shot and is handicapped to this day because of this unfortunate happening.

The other case was a near tragedy. It involved a young teenage boy and a man into whose house he was looking. The adult took it upon himself to shoot this young man instead of calling the police. The victim in this case was in a very bad way for a long time. If he had died? What suffering! What untold suffering! For what?

I submit that we do not live in vigilante times and it behooves us not to take the law into our own hands.

There is a song and one of the lines says, "When will we ever learn? When will we ever learn?"

I certainly hope that it will not take a real tragedy to awaken us.

New Jogging Program Begins in Greenbelt

The city is now accepting registration in its first official "Run For Your Life" program, which will begin Tuesday night, September 9. The three-times-a-week program was sparked by the release of medical figures showing that more middle aged men die of heart disease than any thing else, despite these words of advice several years ago by a leading national expert: "If you want to prevent a heart attack, if you want to recover from one, run."

To make it easy for Greenbelt residents to get out of their easy chairs, the Recreation Department will have program leaders on hand between 6:30 and 8 p.m. on Tuesday and Thursday nights each week and from 9 to 10:30 a.m. each Saturday morning rain or shine. The leaders will pace joggers, coach them, and answer technical questions. To add a little extra incentive, trophies and a Governor's physical fitness patch will be awarded to those who during a 13-week period participate in 13 jogging sessions and who run a total of 65 miles during that time (an average of 5 miles a week compared to Jim Ryun's 15 miles a day!).

The program is open to both sexes and to people of any age. To register call 474-6878. Although medical certification is a prerequisite to registration, the recreation department will give a free "step test" in lieu of an examination, but those who fail to qualify will have to obtain a medical certificate. Tests will be arranged by appointment with the Recreation Department and information about running and on the program will be distributed to those taking the test or delivering their certificates.

The Run For Your Life program is intended to be a pilot study for other similar programs to be started elsewhere. It is being directed by Larry Noel, past president of the DC Road Runners Club and director of the monthly jog-alongs, and Hugh Jascourt, the creator of the national Run For Your Life program, a past coach-manager of several U.S. international teams, and a recipient of the physical fitness leader's award given by the Jaycees and the President's Council on Physical Fitness.

New Bank for Greenbelt?

The city has received from the Maryland National Capital Park and Planning Commission the preliminary plan of a subdivision for the corner of Edmonston Rd., Greenbelt Rd., and Kenilworth Ave. Directly across Edmonston Rd. from the Junior High School, the .5970-acre property has been purchased for a bank building, city officials have been told. The property is zoned C-O.

HOFF
 William Hoff has resided in Greenbelt for 16 years and was elected to the City Council of Greenbelt in 1963, 1965 and 1967. He has served as chairman of the city's Personnel Board and has been a member of the nominations-elections committee of Greenbelt Homes, Inc.
 Hoff and his wife, the former Amelia Ann Enkemann, live at 71-E Ridge Road. Mrs. Hoff is a registered nurse. The Hoff's have two daughters.
 A lifetime resident of Maryland, Hoff was born and reared in Cumberland. He graduated from the

University of Maryland in 1949 with a degree in public and business administration. Since then he has been director of the university's student union, gathering center for the 30,000 students at College Park.
 During World War II he was commissioned a lieutenant at Fort Benning, Ga., and served in the 29th and 98th Infantry Divisions.
 Hoff has been a member of the 29th Infantry Division Association, the Society of Personnel Administration, the National Association of College Unions, and Sigma Nu social fraternity. He is a member of Mowatt Memorial Methodist Church of Greenbelt where he teaches a Sunday School class. Twice he has been president of Chapter 21 of the Maryland Classified Employ-

ees Association, and was in charge of conducting for that organization a nationwide survey of longevity-pay programs in various states. He is a member of and an advisor for the University of Maryland chapter of Omicron Delta Kappa national honor society, which recently presented him with a certificate of meritorious service.
SMITH
 Edgar L. Smith is serving his third term as Mayor of the City. He is an attorney with law offices in Greenbelt and is admitted to practice in the State of Maryland and the District of Columbia. He has an Associate of Arts Degree from the Maryland State Teachers' College at Salisbury, a Bachelor of Science Degree from the Univer-

sity of Maryland at College Park and an LLB Degree from the University of Maryland School of Law in Baltimore.
 Smith was selected "Outstanding Young Man of America, (1964-1965)" by the United States Junior Chamber of Commerce, a member and past president of the Greenbelt Democratic Club, a member and past president of the Greenbelt Business Men's Association, an associate member of the Greenbelt Volunteer Fire Department and Rescue Squad, a member of the Board of Directors of the Greenbelt Boy's Club, and a member of the Greenbelt American Legion.
 Smith was one of the organizers and is a member of the "Citizens for a Planned Greenbelt." He ser-

ved on the Greenbelt City Council from 1959-61, was City Solicitor from 1962-63, and was again elected to the City Council in 1963, at which time he became Mayor.
