City Election Tuesday Seven Vie for Council

About 1,500 Greenbelters are expected to trek to the polls next Tuesday, September 16, to cast their votes for the five city council members who will head the municipal government for the next two years. The three polling places at the Greenbelt Municipal Building (3rd precinct), North End Elementary School (6th precinct), and the Springhill Lake Community Center (8th precinct), will be open from 7 a.m. to 8 p.m.

All five incumbents are seeking re-election. Mayor Richard Pilski, Gil Weidenfeld, Charles Schwan, Thomas X. White, and Richard Castaldi. Two other candidates competing for spots are Jack M. Queen and Virginia Moryadas. Biographies of the candidates appear on page 4.

Election Procedures

All council members are elected at large. In order for a candidate to be elected, he must receive 40 percent or more of the votes cast. If fewer than five candidates receive such a vote, a run-off election will be held one week later on Tuesday, September 23.

In the run-off election, the ballot will consist of those unsuccessful candidates receiving the highest number of votes, up to twice as many names as there are positions to be filled. Candidates polling the greatest number of votes are declared winners in the run-off election, regardless of the percentage of votes received.

The 40-percent requirement for election was introduced in 1967. Prior to that a majority vote was required, usually resulting in run-off elections. Since 1967, no run-offs have taken place.

Each voter is entitled to vote for five candidates. Voting for fewer than five obviously increases the possibility of a run-off election.

Registration Count

The number of Greenbelters registered to vote is 3,053, down 14% from the 3,568 registered in 1973. Only 54 percent of the registered voters cast ballots in 1973, with the highest percentages registered in North End (62%) and Center (59%).

This year the Center precinct had 1,243 registrants; the North End precinct, 1,139; and the Springhill Lake precinct, 671. Springhill Lake had the greatest drop in registration — 33% from its 1973 total of 997. North End had an 11% drop, while Center had a 4% drop.

If all five council members are elected September 16, there will be an organizational meeting on Monday, September 22 (This meeting is set by charter.

Upon being sworn in, the newly elected council members will choose the mayor. Although the charter

Labor Day Race Results

A total of 191 people finished the two-mile and the 15 kilometer (9.3) mile races held as part of the Greenbelt Labor Day Festival on Sunday, August 31. The weather was good for running the longer race, but the lake path was wet and muddy. Seventeen Greenbelters finished the two-mile which had 97 finishers, including some families, many women and children, with everyone receiving an award. The race was won by Paul Repavi in 10:11, a high school runner from Fairfax, Va. The first female was Dottie Rowe, 19, from Gaithersburg, Md., one of the best in the Washington area, who finished 9th in 11:31. Andy Feeny (19) of Northway was the first Greenbelt, finishing 4th in 11:01.

The featured 15 kilometer race had a field of 94 finishers, and was won by Al Naylor, former high school miler from Northwestern in 50:17.4, just 2 minutes and 32 seconds behind the record set in 1973 by Jack Fultz. There were nine Greenbelters who finished this race led by Jim Isenberg (24) of Ridge Road who finished 14th in 54:35. Others were Tom Noel (14) 28th in 57:48; Ken Brown, Springhill Drive (31) 38th in 59:34; Marty Greenbaum (30) 39th in 59:48; Milt Greenbaum (23) 53rd in 63:11; Larry Wenzel (23) 59th in 64:21; Bill Bishop (41) 71st in 66:27; John Hanyok (22) 73rd in 66:29 and Hugh Jascourt (40) 85th in 69:42. Five women finished this race led by Anna Mae Diehl of Arlington, Va. in 63:26 for 56th place. A complete list of all finishers will be posted at the Youth Center.

Council Holds Final Meeting of Term

As is becoming traditional with the Greenbelt city council the last meeting—on Monday, September 8, 1975—before elections was all sweetness and light. It wasn't maudlin' or a lot of sentimental nonsense, but just the very nice kind of discussion that sort of confirms that Greenbelt is a place where, despite differences, you can end up liking each other.

The first good thing to happen was the introduction and official welcome to Greenbelt by council, of the Huol family, refugees from Cambodia (see last week's issue). Attending with Mrs. Huol and her four children were Joe Mulvihill, who spearheaded the St. Hugh's sponsoring activities, and Mr. and Mrs. Francis Scott, 3 Olivewood Court, with whom the family is living during their stay in Greenbelt.

Mayor Richard Pilski surprised everyone with a nicely rendered welcome speech, all delivered in French in deference to Mrs. Huol who could speak no English. Also, in English, he spoke of how this action — bringing the Huol family to Greenbelt — represented the best traditions of America.

Councilman Charles Schwan was also eloquent in his welcome, speaking of how "our own largesse enriches us." Councilman Richard Castaldi stated that he hoped the family's stay here would be as gratifying as living in Greenbelt has been to him.

Councilman Gil Weidenfeld spoke of what a friendly place Green-

belt is and how the family should feel free to call on council. Finally, councilman Thomas White stated that he wished to commend the people of Greenbelt for the warm response they have given to the family, and particularly the Scotts, Joe Mulvihill and Msgr. O'Donnell for their special efforts.

Deferred Items

Council then hastily moved through a number of items of business, most of which were deferred to the next elective council for final action. Three APB reports, relating to zoning map amendments for Cipriano property and the Beltway-Greenbelt property, and recommending against one-way traffic on Parkway Road, were accepted from the chairman, Donald Volk.

Two ordinances relating to tax credits for the elderly and disabled were remanded for amendment to place them in conformity with county ceilings after Mrs. Green and Mr. Kendall, members of the audience, spoke of the confusion they were having between city and county forms and differing rates for deductions.

Other Action

Council approved a bid award of \$3,280.33 for a fifteen station circuit trainer gym machine for the new Springhill Lake Recreation Center from the Atlantic Health and Fitness Products of Glen Burnie, Maryland. Council also deferred action on a request for a three year extension of lease by Gunner's Mate, Inc. for the concession stand at the Lake Park and swimming pool. Jan Kuhn of Lakeview Circle thought council should let the park revert to a natural state which would offer less encouragement to outsiders to use it. She and members of the council stated that any questions they might have did not relate to the manner in which the concessions were operated by the Bowmans which they felt was commendable.

Council, on a motion by Schwan, approved a \$100 contribution to the Young America group of St. Hugh's to assist them in traveling to Florida where they will perform as one of the American History group selections of the Freedom Foundation. Mayor Pilski was also authorized to approach the Bicentennial Committee to act as sponsor for the group.

Council received a staff manning survey report and recommendations from a committee of Greenbelt Police Lodge #32, Sgt. Smith, Chairman. Also received was the resignation of James Gianfagna from APB. Gianfagna, who is moving to Columbia, Md., was lauded for his efforts on behalf of the city.

The meeting drew to a close with Mayor Pilski stating that he had derived a great deal of satisfaction from city affairs during the past two years, while Schwan thought everyone worked well together. White also stated he had a rewarding first term and complimented the city staff "for never causing me embarrassment because of the manner in which they performed their functions." Castaldi also enjoyed his term and Weidenfeld thought that, despite differences at times, it had been a productive two years.

Manager James Giese said that he wouldn't try to compare this council with previous ones "particularly with a former councilman sitting here taking notes for the News Review," but felt that it had done a very steady and productive job. Finally, the Rev. Bucher stated that, after sitting through many council meetings, it is his conclusion that this council has done a "great job in meeting the challenges of the past two years." It was all rather nice.

Last week Carolyn Crowley was omitted from the list of people placing in the Novice Meet. She placed second in the 10 & under girls freestyle.

NO RESERVES?

Let us start with our operating reserves of \$614,344 restricted for specific purposes as designated by our board of directors.

Let the members in on this secret, give them a breakdown of expenses. They might object to paying \$94,547 to buy back homes, and not selling them again. Those are frozen assets. Try to pay your taxes with that asset.

The members might object to putting up the investment money for appliances etc. to make a few members happy. Can we afford to tie up \$67,179 of your money?

The members might object to an inventory high of \$119,500 perhaps half in oil and get no credit for same. The members were charged for the oil left in the tanks at the end of the year.

The frames should object to a \$63,000 billing toward the moratorium in 1975, when only \$11,623 was earmarked for same, with a possible \$17,000 for boiler improvement. But the \$301,000 for repair & maintenance may include that figure. (from U.S. INCOME TAX REPORT.)

Our By-Laws allows the Board to use MONEY AVAILABLE — but as long as we have an outstanding loan at Suburban Trust of \$585,000, there simply is no money AVAILABLE. The members should demand an accounting of that loan.

The unrestricted reserves amount to \$122,729. There has been a yearly increase for the frames of 10%, but this year they are paying 17% without even knowing it. The frames are in the unique position of paying for improvements they did not get, and may never get, unless the members show some interest in how their money is being allocated by their board of directors.

The board owes the members an explanation about a \$245,000 deposit in a local bank, not in treasury certificates, and marked as G.N.M.A. account. As only about \$147,000 was left of the moratorium money for heating improvements, where does the extra \$100,000 come from?

Could it be the \$94,547 repurchase of G.H.I. units covers that sum? This question should be most interesting to the membership.

Some of the men manipulating your G.H.I. funds are presently asking for your vote as city council. (A good bedside manner does not necessarily make him a good doctor.)

All figures are taken from Arthur Andersen 1974 audit or the 1974 U.S. Income Tax Report.

He has been employed as a tax representative and consultant for Prentice-Hall Inc. for the past 17 years.

Pilski attended King's College, Wilkes-Barre, Pennsylvania, and holds a B.S. degree in Business Administration from Syracuse University. He is a member of the Lambda Chi Alpha Fraternity. He also served three years in the United States Navy.

Mayor Pilski currently represents Greenbelt as Vice-Chairman of the National Bicentennial Committee and on the National League of Cities' Transportation Committee. He also serves on the Council of Government's Board of Directors and the Energy Policy Committee. Previously, Pilski has represented Greenbelt on the Prince Georges County Tax Differential Committee, the Executive Committee of the Maryland Municipal League, and the Environmental and Public Safety Committees of the Council of Governments.

Locally, he has served on the Charter Review and Advisory Planning Board Committees of the city; board of directors of Greenbelt Credit Union, Manager of Minor Leagues; and President of the Lakewood Citizens Association.

Pilski is currently active in the Greenbelt American Legion, the V.F.W. and the Greenbelt Lions. He serves as a citizen counselor to the Prince Georges Boy Scouts and to the Greenbelt Troops.

JACK QUEEN

Jack McKee Queen, 8038 Lakecrest Drive, was former Chairman of the Speakers Bureau for Com-

mon Cause in Prince Georges County, a position he held for the past two years.

Queen is presently a member of the city's Advisory Planning Board. He also represents Greenbelt on the Washington Metropolitan Council of Governments Human Resources Committee and the Housing Technical Committee. Other community activities include membership on the Civitan Club board of directors.

Queen is a graduate of Prince Georges county schools and the University of Maryland. His degree is in public administration and he has also done graduate work in city planning. At present he is employed at Aero Mayflower Transit Co. as a transportation consultant. Queen was a legislative aide to Congressman Ken Hechler (D, W. V.) before working with Mayflower.

Queen has lived in Greenbelt for 7 years. He and his wife, Liz, have one son, Jon.

CHARLES SCHWAN

First elected to council in 1971 and re-elected in 1973, Charles Schwan's prior service to the city includes his having been chairman Advisory Committee to city council on planning (1959-60), member, Charter Review Committee (1966-67), and chairman, Indoor Swimming Pool Committee (1971). During his tenure on council, Schwan has been a member of the Land Use Policy Committee, Metropolitan Washington Council of Governments. Since its inception he has served as a member of the Greenbelt Bicentennial Committee.

A member of the Greenbelt Homes, Inc., Board of Directors from 1963 to 1971, Schwan served as president from 1964 to 1970. His other community activities have included his being a member of the Steering Committee, Citizens for a Planned Greenbelt; co-chairman, Greenbelt Freedom of the Press Committee; and chairman, GHI Advisory Committee on Housing for the Elderly.

Schwan received an A.B. degree from Hiram College, and did graduate work in political science at Syracuse University. There he was variously a Graduate Teaching Assistant, Fellow, and Instructor in the Maxwell School. He served in World War II until discharged a captain in 1945. He was Washington Representative of the Council of State Governments from 1952 to 1962, when he became Director of the Council's Washington office.

At various times during these years he served as principal staff aide to the National Governors' Conference on intergovernmental aspects of roads and highway safety, corporation taxation, natural resources and environmental health. In 1968, he became a partner in Wendell and Schwan, Consultants on Governmental Affairs. The following year he joined with others to form Environments for Tomorrow, Inc., a consulting firm organized to assist public and private entities in meeting environmental requirements. In February 1973 Schwan retired from both of the firms.

Schwan participated in drafting the Water Resources Planning Act, and the Multistate Tax Compact. He is the author of articles and reports on federal-state relations, federal grant-in-aid requirements, multi-state taxation, highway safety, and radiation protection.

Schwan has resided for 22 years at 7-A Crescent. He has three children - Peggy at home, Paul, who resides with his wife in Greenbelt and Charles III, who resides with his wife and two children in Lanham.

GIL WEIDENFELD

A graduate engineer and an attorney, Gil Weidenfeld is serving his second term on the council and presently serves as the Mayor Pro-Tem. Weidenfeld is the vice-president of the Prince Georges County Municipal Association. He is the Association's representative on the Legislative Action Committee of the Maryland Municipal League and was recently reappointed to

serve in that capacity for another year. Weidenfeld chaired the Municipal Conference of the Association this year, and last year served as the Chairman of two of the Association's committees, Policy and Political Action. He received a special citation from the President of the Prince Georges County Municipal Association for his outstanding work on behalf of municipalities. Weidenfeld also serves on the Public Safety Policy Committee of the Council of Governments.

Weidenfeld, an employee of the U.S. Patent Office, is presently assigned to the Presidential Clemency Board as a Principal Deputy Assistant General Counsel. In July he received an autographed picture of President Ford personalized "To Gil Weidenfeld with appreciation and best wishes" as a form of special recognition for his work in the President's clemency program. He has earned numerous governmental awards for superior performance, special achievement and for work of outstanding quality.

In 1969 Weidenfeld earned a law degree, Doctor of Jurisprudence, from Catholic University in Washington, D. C., and in 1960 he received a degree in engineering from Rutgers University in New Jersey. He is a member of the Maryland Bar.

Weidenfeld, a ten-year Greenbelt resident, lived in Springhill Lake for eight years prior to moving to Boxwood Village in 1973. 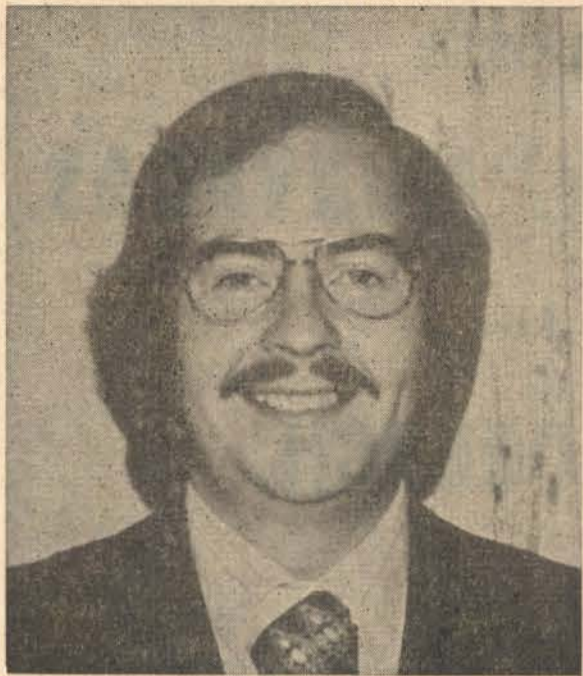

Please Give Me A Minute Of Your Time

As Tuesday, September 16 draws nearer, the candidates for City Council enter the home stretch of their campaign. Whether the candidate just started his campaign after Labor Day or whether the candidate has been out working hard for the last two months (as Jack Queen has), the next few days are very important. The next four days are the last chance to touch the minds of the voters.

Qualifications:

Jack Queen has put forth a special effort to win the confidence and the support of our community with his own unique qualifications. A few are listed below.

1) Queen's main qualification for public office is his devotion to integrity in politics — a public office is a public trust. As Chairman of the Speaker's Bureau for Common Cause, Queen has been monitoring the conflicts of interest of office-holders for several years.

2) Who would be better qualified to deal with problems of city management than Jack Queen? He has formal training in City Management and City Planning.

3) Although Jack Queen has served on local boards (Advisory Planning Board, the Council of Government Human Resources Board and the Housing Technical Committee) he has also worked at the national level as an aide to U.S. Congressman Ken Heckler. (Democrat, W.Va.). Queen understands how senseless duplication of efforts at the local and higher levels of government costs the taxpayers dollars.

4) Jack Queen has had the opportunity to visit with most Greenbelters to rediscover the good spirit of this unique town and also to discuss some of the annoying problems. Although Queen hopes to get to each door, he has publicized his address and phone number for those he may miss.

Goals:

Based on his own survey of Greenbelters, Jack Queen has some goals for the next council. A few are listed below. He will continue to listen for others.

1) Comprehensive public disclosure of campaign contributions. The present law is very weak.

2) Better crime protection against petty thievery and other nuisance crimes. (A better mix of foot patrol and squad cars deserves strong consideration).

3) Increase tax relief for the elderly on fixed incomes. Seek ways to lower or at least maintain present taxes for all Greenbelters through wiser spending programs and Revenue Sharing.

4) More citizen input in consideration of the housing project for the elderly.

5) More realistic transportation for the elderly and the handicapped . . . A mini-bus deserves strong consideration over a large bus.

6) Encourage more community participation and communication in city council meetings.

7) Safe bikeways are needed. A permanent bathroom facility would be most desirable at the Greenbelt Lake.

8) Encourage better ties between the older and newer sections of Greenbelt, to preserve the uniqueness of our small town community.

A Message to Greenbelt Residents

From Mayor Pro-Tem Gil Weidenfeld

5. Construction of METRO (Rapid Rail Transit)

The METRO system now under construction is planned to have one line from D.C. to Prince George's Plaza and end with a station in the vicinity of Greenbelt Road and the

B&O Railroad. Recently, there have been proposals to change this route so that it will end in the vicinity of I-95 and the Beltway with direct access to the station parking lot from these highways. A major problem of METRO is that due to inflation there are not enough funds to complete construction. This County's share of funds was raised by the issuance of bonds to be repaid out of County taxes and, unless additional grants from the Federal government are obtained, it may be necessary to issue more bonds to complete the project or reduce the length of the system.
