## COUNTY COUNCIL VIEWS ON METRO SUBJECT TO CITIZEN REACTION

The controversial Greenbelt METRO line will be the subject of a public hearing on Monday, October 20, at 7:30 p.m., in the Adult Education Center, University of Maryland. The county council, which will conduct the hearing, has stipulated certain conditions that it would like to attach to the different alternative alignments suggested for the Greenbelt "E" route going north from Prince Georges Plaza.

The first condition is that alternatives 18 and 19 be dropped from further consideration. These are the routes that travel up Adelphi Road and end at I-95 and the Capital Beltway (I-495). Also recommended for elimination is alternative 21, planned as a tunnel route to cut across the University of Maryland's golf course.

The county council does not rule out an alignment ending at I-95, but stipulates that if alternative 20 is considered, it should be tunneled through its entire length from University Boulevard northward until it is beyond the last residential area and then should surface in the vicinity of the PEPSCO right-of-way.

The council further stipulates that any alternative involving direct connection with I-95 should have all terminal facilities; i.e., station, parking, and storage/inspection yard, located within the I-95/I-495 interchange or on the northern side of I-495.

Of most interest to Greenbelters, the council does not rule out alternative 22, or the ARS alignment. Alternative 22 would run north of Prince Georges Plaza and west of the University of

Maryland to University Boulevard and then loop east to a terminal near the Baltimore and Ohio railroad tracks and Greenbelt Road. The ARS alignment is the original alignment, which called for the subway to run along Queens Chapel Road to the east side of College Park and then parallel the B&O tracks north to Greenbelt Road.

The council's position is that if further consideration is given to alternate 22, appropriate test borings should be undertaken in the area and no station constructed in Berwyn.

The council suggests that if alternative 22 or ARS is selected, a study be made of a "METRO only" access road from the Capital Beltway to the terminal station.

The council stipulates that in those areas where a preferred alternative is likely to have a substantial impact on a residential area, or a damaging effect on existing parkland, the line should be placed underground. In no case should the Greenbelt route be terminated at Prince Georges Plaza or the University of Maryland, the council said.

## Citizen Poll Shows Support For Nearby METRO Station

The city has now tabulated the preliminary results from the battery of questions asked local citizens at election time about the METRO system. In general, the Greenbelt public supports the concept of the subway, is ready to shell out more money to complete the system, and strongly prefers a terminal station on Greenbelt Road near the B & O railroad tracks.

The citizens also favor a METRO stop at the University of Maryland between Greenbelt and Prince Georges Plaza, even though there will be added expense, and favor putting the subway underground in areas occupied by homes, despite the additional expense.

The most lopsided vote came on the question of constructing METRO to the vicinity of Greenbelt Road and the B&O railroad as opposed to running the subway to I-95 and the Beltway. 77% of those responding favored the Greenbelt Road route, 13% opposed, 10% undecided. At the same time, 56% opposed the I-95 route, 23% favored, and 21% had no opinion.

Of major interest countywide is probably the vote on raising additional funds to complete the Metro system. 66% approved this, 23% opposed, and 11% undecided. The margin in favor was highest at Springhill Lake, lowest at North End precinct.

The next overwhelming vote was in favor of a METRO stop at the University of Maryland. 61% favored this, 23% opposed, 16% no opinion. Underground construction was favored by 52%, 29% opposed, 19% no opinion.

Finally, a question was asked on individual expectation to use METRO regularly. 49% responded yes, 31% no, and the remaining 20% had no opinion. Here, Springhill Lakers showed a greater inclination to use METRO than the other two Greenbelt precincts, a finding not unexpected in view of the proximity of the METRO line.

## Attorney General Washes Hands of GHI Charges

Greenbelt Homes, Inc. has received word from the Maryland Attorney General's Office that the allegations of possible fraudulent activity on the part of the GHI board of directors and members have been referred to the Prince Georges County State's Attorney. In a letter dated October 7, 1975, Assistant Attorney General Ward B. Coe III stated that since the allegations involve possible criminal action and his office is not empowered to conduct a full investigation, the material and files have been transferred to the office of Arthur A. Marshall. Coe said that his office merely reviewed the allegations to determine whether any basis for them exists.

The charges were submitted to the Attorney General by GHI member Martha Hutzler and associates last March.

## GHI Wins Tax Appeal; 3-Year Refund Estimated at \$250,000

Greenbelt Homes, Inc. has successfully pursued its tax appeal case. In a decision handed down on October 7, the Maryland Tax Court ruled that GHI was entitled to a \$1,570,350 reduction in its real estate assessment. The county assessor had in December 1971 increased the assessed valuation of GHI properties from \$7,840,570 to \$11,621,500 (later reduced to \$11,541,960). The county Property Tax Assessment Appeal Board in May 1973 upheld the assessor but the decision of the Tax Court has now reversed the Appeal Board and set the new assessment value at \$9,945,290 (\$9,971,610 after allowing for individual additions to homes).

For the fiscal years 1972-73, 1973-74, and 1974-75, GHI had paid taxes on the basis of the \$11,541,960 figure. It is therefore now entitled to a three-year refund which, according to the calculations of GHI officials amounts to \$251,375 after allowing for interest. About one-fifth of this amount or \$50,000 is to come from city coffers, the rest from the county and State treasuries.

In December 1974, the county assessor raised GHI's assessment again — this time to \$12,351,350. GHI will have to continue paying taxes on this amount until an agreement is reached with the county assessor as to how the Tax

Court decision affects the current assessment.

In its decision, the Tax Court held that the county assessor, by using the sales price of GHI as the basis for assessing improvements, did not allow for sufficient depreciation of the homes. Pointed out were such factors as termite damage, deteriorating walkways, inadequate parking, and the need for interior and exterior painting. The court ruled that an additional allowance of 15% for depreciation should be granted, reducing the assessed valuation of the homes and improvements by \$1,256,400.

The Tax Court also ruled that the assessor had overvalued the current value of the land by presuming certain site costs that were not applicable to GHI properties. A 10% reduction in this value to \$26,000 an acre accounted for the remaining \$313,950 reduction in the assessed valuation.

The Tax Court decision can be appealed by the county to the Circuit Court. Successfully representing GHI in the appeal was attorney Albert Ginsberg.

## City Reviewing Complaints Against Police Dept.

Responding to complaints voiced at the October 6 meeting of city council, the city administration has begun a systematic review of the allegations made against the police department.

In a series of meetings, police chief William T. Lane has met with city manager James K. Giese and the members of the police department in an effort to catalog the complaints and identify the incidents referred to. Chief Lane has also written, called and met with many persons who spoke up at the council meeting.

Reportedly, the major concern of the police force is that some of the citizens at the meeting were attempting to relax the enforcement of laws and to have pending charges dropped. They were advised by Lane and Giese that no directives were being issued to ease off on the enforcement of law violations and that all officers were expected, as always, to perform their duties in a professional way.

Robert Hardie, chairman of the city's Community Relations Advisory Board, said that the committee will be meeting in the near future to discuss complaints against police. The council had referred the matter to CRAB for recommendations.

In the meantime, Giese reiterated that anyone with complaints or questions concerning police procedures should call him, chief Lane, or assistant city manager Dennis Piendak.

Lane said that anyone can phone, write or personally appear at the department with complaints and questions. "Over a 24-hour period," he said, "there is always a lieutenant, sergeant or corporal qualified to handle these matters, and I am also here during the day."

Lane further said that completing a written form is not necessary for a person to see him or police personnel. The forms at the desk are for everyone's convenience. One advantage of a written communication, he said, is that the inquiry or complaint is more likely to be well thought out and described in more precise language. He stated that the written form is not required to be sworn to or notarized.

## Tom White Honored by GHI

Presentation of an honorary plaque to Thomas X. White marked the opening of the regular meeting of the board of directors of Greenbelt Homes, Inc. on Oct. 9. The plaque, presented by GHI President James W. Smith, was in recognition of White's valuable service to GHI as a board member and as treasurer and on various committees between 1965 and 1973, when he was elected to city council. Also singled out for notice were three long-time staff members who retired on the first of the month: Roy Bladen, with 37 years of service to GHI and the city of Greenbelt; William Dobbin, electrician; and Ernest De Gagne, painter.

Staff engineer George Craft submitted to the board a possible alternative he had worked out for a pilot project on heat conservation. The board heard this with interest, commended the maintenance department for its initiative, and referred the suggestion to the engineering and maintenance committee for consideration.

Much time was spent on a member's request for permission to run electricity to a freezer in a shed. Two compromise motions failed and the request was denied after board members pointed out that granting this request could lead to a violation of the recent county moratorium on electrical heavy-ups.

A drainage problem was brought to the board by a GHI member who said that water pours in under her addition and that the insulation is soaked through and hanging in strips. Director Hugh O'Donnell, who had inspected the site, confirmed the member's statement; several additions are under construction in her row, he explained, and are blocking the swale, which has only one small drainage pipe. The result, O'Donnell pointed out, is that water from the slope rising beyond the swale, as well as runoff from the roofs of the six homes, pours into the complaining member's addition, creating a serious problem with which the corporation must deal.

Membership hearings on the proposed 1976 budget for Greenbelt Homes, Inc. were announced for the evenings of Wednesday, Oct. 29 and Thursday, Oct. 30 in the city council chamber.

Senator Edward T. Conroy was informed today by the State Highway Administration that notice to contractors has been posted for sealed bids to be received by the State Highway Administration on October 21 1975 for the construction and marking of a bikeway along Greenbelt Road starting at Lakecrest Drive and extending to 57th Avenue in Berwyn Heights for 1.49 miles.

# Letters to the Editor

## Police Response

To the Editor:

We, as an organization of professional Law Enforcement Officers, feel it necessary to comment on the blatant allegations lodged against the Greenbelt Police Department at the October 6, 1975 Greenbelt City Council meeting. Unsubstantiated complaints ranging from verbal abuse to brutality were alleged to a receptive city council. For those Greenbelt citizens who were not present at the October 6 city council meeting what transpired may have been reported as truly representative of the total community's attitude toward the Police. This fortunately was not the case. What the Greenbelt City Council heard was that small, but vocal, group of individuals who represented that portion of the community that has had frequent encounters with the police because of either their own, or a member of their family's unlawful conduct. Many, because of their own misunderstanding of existing laws, questioned the enforcement of such laws dealing with carrying concealed weapons, feeling that they had the lawful right to do so. Therefore, such baseless complaints were made that Greenbelt police officers were infringing upon their inalienable rights to carry concealed weapons when the police officers arrested them for carrying a concealed weapon. Such misunderstanding of the law and accepted police practice went unabated at the October 6, 1975 Greenbelt City Council meeting. More succinctly stated, this group of individuals joined together to express their rebellion against the established community. Their rebellion is basically rooted in the feelings of hostility, ambivalence, apathy and indifference. It is hoped that the total community can candidly consider the reliability and validity of these allegations of Police misconduct.

While some have already formed their own opinion concerning these allegations and even expressed them to others as hard facts, we feel that many are still looking for answers. As such, we recommend that an immediate investigation into these allegations of police wrongdoing be conducted. The investigation should be conducted openly, thoroughly, and honestly, with its findings reported publicly. If this were done, we believe it would help eliminate any misconceptions and mistrust, and instill public confidence once again in the Greenbelt Police Department.

It is for this very reason we cannot stand by silently and tolerate unwarranted allegations of police misconduct that discredit the Greenbelt Police Department, which has established a reputation for professionalism and service.

We only ask, as professional law enforcement officers, that these allegations of police misconduct be investigated thoroughly and the findings be reported to the public in order to determine where the truth lies.

## Help With Complaints

To the Editor:

I was recently invited to a conference with Police Chief Lane. At this meeting I found the Chief quite open and anxious to get to the bottom of the complaints concerning police misconduct. He said he's interested in restoring the name of the department. This means that an investigation of each complaint must be made so that both sides may be heard in determining the correctness of an individual officer's conduct. However, there must be a specific complaint.

This is where we stand now. A number of general complaints have been made about the department. I congratulate all of you who spoke at council and I for one believe that your complaints are worthy of a full investigation.

However, the investigation cannot begin concerning an individual officer until you make an official, specific complaint. It should be written, and in the case of brutality, Maryland law reads: "No complaint . . . alleging brutality . . . shall be investigated unless the complaint be duly sworn to before an officer authorized to administer oaths."

This does not mean that you cannot talk to someone first. Chief Lane, several council members, members of the board of Greenbelt CARES, community relations people and at least one ACLU lawyer have all expressed a willingness to discuss complaints and recommend a course of action. If you have a real complaint and are confused about how to express it, Ricky Barber and I will be open to you to help contact responsible officials, get your complaint written, or serve you in any other way we can. Ricky Barber is 474-6462 and Rick Ransom is 474-5683.

It is your right and your duty to report police misconduct, and Chief Lane has promised me he will personally act to prevent retaliation or harassment should you experience any from exercising your right to complain.

## A Question of Law

To the Editor:

At the last council meeting a deliberate attempt was made by an element of this town's population to discredit our police force and to arouse public sentiment against the police. Although it was stated that criticism was aimed only at 'one or two' officers, I think it is obvious that the department as a body was under attack. More than 80 people reportedly were present to complain of alleged police misconduct, because of a fear that individual complaints would be retaliated against if the normal channels for grievances were used. Sixty-five reportedly raised their hands when Councilman Pilski inquired if they were there to report brutality. Could 'one or two' officers really have brutalized 65 people? I doubt it. Could 'one or two' officers retaliate against 80 separate complaints? Unlikely. Would the 'good' officers have retaliated on behalf of the one or two officers who allegedly wronged all those people? No. Have all of those people really been victims of misconduct, harassment or brutality? Undetermined at this time, but you wouldn't know it from the behavior of two of the councilmen present, as they appeared quite ready to believe all, without investigation or evidence. Fortunately, the other council members and the city manager retained their sense of balance.

The impression that a careless thinker would form from reports of this meeting is that Greenbelt has a police force that habitually beats children, uses dirty language to innocent young girls, cages orderly citizens, generally abuses its authority, and retaliates against those victims who complain (that is, when it is not busy ignoring their complaints). Untrue. Greenbelt is not a police state, as we are led to believe. Let us look at the other side of the coin.

It was mentioned during the meeting that physical attacks on police officers have increased. The reaction of the orderly but upset crowd? Applause! There were complaints of police arbitrarily enforcing laws. If a law exists, and a violator is arrested, what is arbitrary about that? There were complaints of police harassing persons by repeatedly ticketing them for minor traffic infractions. If a minor violation of the law is observed, be it traffic or otherwise, is an officer supposed to ignore it because it is minor, or because the same person has more than once been observed in violation? Is this harassment? Or are we meant to understand that the police are making numerous false arrests? I do not feel that the methods of law enforcement are really in question here, but rather it is the law itself, the authority of the police to enforce the law and the honesty of the police

that are in question. I strongly urge those who would complain of police tactics to separate themselves from those who object to the law and its processes. To any person who sincerely feels he has been wronged by the police, I would suggest that caution be used if you are approached by a 'sympathizer' who may not be interested in obtaining justice, but simply in using you to create an anti-police sentiment.

If 'one or two' officers are indeed being accused of misconduct or dishonesty, then let the path of investigation be free of prejudice and irrelevant hostility. The laws apply to the officer as well as to any other individual. So too is the officer protected by law, and his rights are not to be abridged. The alleged grievances have been publicly aired. Let us hope that the specific officer(s) who may be affected can obtain a fair investigation by the proper authorities, and through appropriate legal methods. My respect for, and faith in, the Greenbelt Police are unshaken, and I support its continued existence as this City's law enforcement agency.

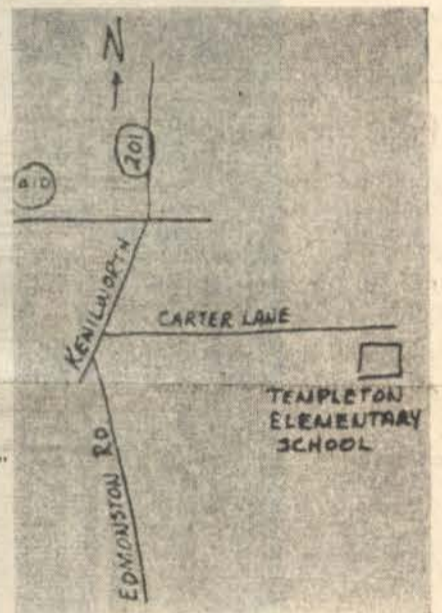

# COUNTY COUNCIL HEARINGS

## COUNTY COUNCIL OF PRINCE GEORGE'S COUNTY, MARYLAND NOTICE OF PUBLIC HEARING

on

### CR-92-1975 - ADOPTING POLICY GUIDELINES WITH REGARD TO THE PROPOSED METRO GREENBELT (OR "E") ROUTE IN PRINCE GEORGE'S COUNTY

The County Council of Prince George's County, Maryland, hereby gives notice that it will hold a public hearing on proposed Council Resolution No. CR-92-1975, on

MONDAY, OCTOBER 20, 1975  
7:30 P.M.

The text of CR-92-1975, follows:

WHEREAS, alternative alignments for the proposed METRO Greenbelt (or "E") Route in Prince George's County have been under intensive study and analysis for more than a year, including the preparation of a detailed environmental impact statement by Wallace, McHarg, Roberts, and Todd for the Washington Metropolitan Area Transit Authority (WMATA); and

WHEREAS, the environmental analysis estimated the probable impacts that the various alternatives would have in regard to an array of ecological, visual, and socio-economic factors as a means directing the decision-making process toward a preferred alternative alignment; and

WHEREAS, the WMATA Board held public hearings within the affected corridor on March 12 and May 5, 6 and 7, 1975, and further, the County Council, on July 2, 9, 15, and 16, 1975, held public hearings to ascertain the attitude of County residents toward various issues relating to County participation in the Metro system; and

WHEREAS, upon consideration of the hearing testimony, undertaking a field trip of the study area, and holding work-sessions pertaining to the Greenbelt Route alternatives under examination, the County Council finds that several of the alignments have aroused a substantial amount of harsh public reaction and opposition in that they pose a threat to homes, businesses, and valuable environmental features,

NOW, THEREFORE, BE IT RESOLVED that the County Council desires that Prince George's County have a high quality rapid transit system that will provide efficient and convenient service, respect neighborhood and community integrity, and minimize negative impacts on environmental values; and

BE IT FURTHER RESOLVED that to achieve the above objectives directs the County's representatives on the WSTC and WMATA to act in accordance with the following policy guidelines:

1. In those areas where a preferred alternative is likely to have a substantial impact on a residential area, or a damaging effect on existing parkland, the line shall be placed underground for the purpose of cost estimation.
2. In regard to alignment alternatives described in Volume Two of the Greenbelt Route Environmental Impact Study, the following policies are applicable:
  - a) Alternatives 18, 19, and 21 shall be dropped from further consideration.
  - b) Alternative 20 shall be considered only if (1) the line is in a tunnel through its entire length from University Boulevard northward until it is beyond the last residential area and surfaces in the vicinity of the PEPCO right-of-way, and (2) all terminal facilities, i.e., the station,

parking, and storage/inspection yard are located within the I-95/I-495 interchange or on the northerly side of the Capital Beltway.

- c) If further consideration is to be given Alternative 22 or any alternative involving Adelphi Road, appropriate test borings must be undertaken in the area and the results made available to the public prior to final selection of an alignment.
- d) In the event that Alternative 22 is selected, no station shall be constructed in Berwyn.
- e) In the event that Alternative 22, ARS, ARS-modified, or any other alternative ending in Greenbelt is selected, a study must be made of a "Metro only" access from the Capital Beltway to the terminal station.
- f) Any alternative involving direct connection with I-95 shall have all terminal facilities within the I-95/I-495 interchange or on the northerly side of I-495.

3. Inasmuch as Alternative B-ARS south of Prince George's Plaza (as described in Volume One of the Environmental Impact Study) is opposed by the Council, any further consideration of this alignment shall be for comparative cost and cost-benefit purposes only.

4. In no case shall the Greenbelt Route be terminated at Prince George's Plaza or the University of Maryland. If problems of funding or other obstacles cause a temporary truncation of the route, it shall be terminated at Fort Totten; and

BE IT FURTHER RESOLVED that WMATA is requested to initiate a study to determine the advantages and disadvantages of using parking structures and other design approaches rather than asphalt parking lots at Prince George's Plaza and the Greenbelt Route terminal station. Such a study should include (a) a cost-revenue analysis, (b) an environmental impact comparison, and (c) a size potential analysis (i.e., number of cars and acreage required).

The purpose of the public hearing is to afford all interested persons an opportunity to express their views concerning this proposal. Time limits of three minutes for an individual and five minutes for the spokesman for a group or groups will be imposed. Persons wishing to testify at this hearing are urged to call the Office of the Clerk of the Council (telephone 627-3000, Ext. 200) for placement on the advance speakers' list. To the extent possible within time limitations, those wishing to testify may also register at the Adult Education Center prior to the public hearing.
