## Governor Responds To Pressure From State And Local Officials

Governor Harry Hughes responded in the form of a letter, dated July 20, to pressures he had received against the possible closing of Youth Services Bureau programs. The letter went to government leaders who had written him in support of the YSB's including the highly regarded Greenbelt CARES.

Among those receiving letters were state delegates Joan Pitkin and Gerard Devlin, as well as Greenbelt mayor Gil Weidenfeld. All three had strongly protested the proposed elimination of the programs.

The body of the Governor's letter reads as follows:

"When the volume and potential impact of the Reagan Administration budget proposals became apparent this spring, I requested all Cabinet Secretaries to prepare two plans for my review.

"The first was to accommodate the cuts in Federal funds. I specifically directed that the merit of the programs be addressed and that agencies plan to substitute

State funds for Federal losses if State-funded programs were of lower priority. We must prepare for the decreases, because the money simply will not be available. The shortfall in the Department of Health and Mental Hygiene, depending on decisions about Medicaid, will be between \$15 and \$39 million. (This Department administers the YSB programs. Editor's note.)

"The second plan was for a decrease of three percent from the FY 82 State fund appropriation. This is a contingency plan. The funds could be used to mitigate the Federal loss — by phasing in shutdowns, for example — and/or to meet expected budget deficits

in FY 83.

"Comprehensive decisions about the need to apply three percent reversion plans have not been made. Some of the constituent proposals have been before me in the past, however. One is the possible cut of the budget for Youth Service Bureaus, of which there has been widespread notice.

"I am convinced of the value and the priority of these State-local programs. Maryland is faced with tremendous investment in its prison system. Such immediate demands cannot make us neglect the long-term benefits and solutions that much earlier prevention programs offer. Diversion from juvenile institutions and referral for jobs, family counseling, drug and alcohol treatment programs are worth continuing.

"It is appropriate that Youth Service Bureaus be evaluated individually for effectiveness. However, State support will not be eliminated as a policy in FY 82 and, consistent with the effectiveness review, I expect the bulk of the programs to be funded as planned."

## James, Putens, Zugby Challenge Incumbents In Council Race

Two other incumbents and two newcomers have added their names to those of Mayor Gil Weidenfeld and Ed James as candidates for city council seats in the September 15 election. They are Thomas X. White and Richard Castaldi, both four-term council members, and challengers, Robert Zugby and Ed Putens.

James, who has previously served one term on the Board of Directors for Greenbelt Homes, Inc., is also a founding member of Citizens for Greenbelt. Both Zugby and Putens hail from Greenbelt East, Zugby as a Greenbriar resident and Putens as a resident of Windsor Green. Zugby is President of the Board of Directors of the Greenbriar Community Assn., and Putens chairs a city advisory committee, the Community Relations Advisory Board.

Others wishing to file their candidacies with the city clerk have until next Monday at 5 p.m. Financial statements are due also at that time.

Anyone wishing to run for city council must obtain at least 50 qualified voters to sign a nomination petition form, which may be obtained from the city clerk.

Members of council receive an annual salary of \$2,900; the mayor, \$3,400.

### Registration

Citizens may register at the city offices during regular office hours, Monday through Friday, from 8 a.m. to 5 p.m. Also the city clerk has arranged for on-site registration from now until the books close at three additional places: Greenbelt Homes office on Hamilton Pl., Greenbriar and Springhill Lake Community Buildings. (See city ad for more information.)

Persons who cannot register at those times may request a voter registration form by writing to the City Clerk, 25 Crescent Road. (See city ad for more information.) The last day to register will be August 17.

Once registered, citizens need not reregister as long as they live here continuously and have voted in at least one of the two previous regular city elections. Persons who have never registered here or who have moved out of town and then moved back or who have missed voting in the last two general elections must register again.

As in the past, the News Review will publish biographies of announced candidates as they are received. Biographies of candidates, in alphabetical order, follow:

### THOMAS X. WHITE

Thomas X. White resides at 8 Woodland Way, with his wife, Helen, and seven children. The Whites have lived in Greenbelt for the past 22 years.

White, a native Washingtonian, was educated in the parochial school system there, graduating from Gonzaga College High School in 1953. After attending Georgetown University for one year, he enlisted in the U.S. Navy and served for five years as a Medical Corpsman.

Leaving active service in 1959, White enrolled at the University of Maryland, moving with his family to Greenbelt at that time. In 1962, he earned a B.S. Degree in microbiology and has worked for the past 19 years in the field of medical diagnostic products. At the present time he is on the professional staff of the Science and Technology Division of the Pharmaceutical Manufacturers Association.

White has continued his affiliation with the U.S. Navy as an active Naval Reservist. He is completing his 27th year of Naval Reserve service, and is assigned to a Navy Reserve Surgical Team at Adelphi, MD.

White began his active community service in 1962 when he served with the Greenbelt Jaycees, the Citizens for a Planned Greenbelt, and various committees and elective offices in the Greenbelt Homes Inc. (GHI) Cooperative. He served on the GHI Audit Committee for three years, the GHI Board of Directors for four years, and was Treasurer of GHI during 1973-74. He was one of the founders of the Greenbelt Save Our Community Committee (SOCC), which was instrumental in preventing the location of a planned three-school complex on Parcel 1 and 2 west of the B-W Parkway. The group also led the opposition to the use of a package temporary sewage treatment plant to serve new residential properties in Greenbelt.

White was first elected to the Greenbelt City Council in 1973 and has served four terms. While on the council he has been very active in county, regional, state, and national committees dealing with municipal affairs. These include: Member, Water Resources Planning Board, Metropolitan Wash-

ington Council of Governments (MWCOG); member, Air Quality Steering Committee, MWCOG; alternate member, Metropolitan Interstate Air Quality Planning Committee, MWCOG; member, Environment and Natural Resources Policy Steering Committee, National League of Cities; member, State of Maryland Air Quality Control Advisory Council; and member, Legislative Action Committee, Maryland Municipal League.

White is a member of Greenbelt American Legion Post #136, Citizens for Greenbelt, and the Greenbelt Cultural Arts Center, and is past president of the Eleanor and Franklin Roosevelt Democratic Club. The White family belongs to St. Hugh's Church.

## ROBERT ZUGBY

An independent businessman and former teacher and writer, Bob Zugby has served as President of the Board of Directors of the Greenbriar Community Association since 1979, when control of the association passed from the developer to the homeowners of Greenbriar. In addition to carrying out the administrative duties normally attached to the office, Zugby has frequently served as spokesperson for Greenbriar before the City Council on such matters as zoning and city budget considerations.

In the crisis atmosphere following a mechanical failure in the Greenbriar sewage pumping station in August 1980, Zugby organized and coordinated negotiations among the Greenbriar Boards of Directors, the City Council, members of the County Council, and officials of WSSC. This effort resulted in the transfer of the pumping station to WSSC with safeguards to protect the natural environment of the Greenbelt area, as well as the property of Greenbriar homeowners.

As a member of the Greenbriar Phase III Board of Directors, Zugby is Communications Director of the Phase. The monthly *Communique* newsletter is one of his responsibilities.

Zugby was born in Washington, D.C., and raised in Prince Georges County. A product of the Prince Georges County public school system and of Archbishop Carroll High School, he graduated from the Catholic University of America in 1963, with a Bachelor of Arts degree in biology. After earning additional credits in Psychology and education at the University of Maryland, Zugby taught high school science for four years, and then became a writer and audiotope program coordinator for the American Association for the Advancement of Science and promotion coordinator for Flow Laboratories, Inc., in Rockville. He currently manages his own audio-visual production and sales firm, Elpro Associates, in Takoma Park.

Zugby is active in his church as chair director/organist and member of the Parish Council. He, his wife Dea, and their seventeen-month-old daughter, Kristina Elizabeth, reside in Greenbriar Phase III. Dea Zugby is employed as a training technician at the U.S. Drug Enforcement Administration.

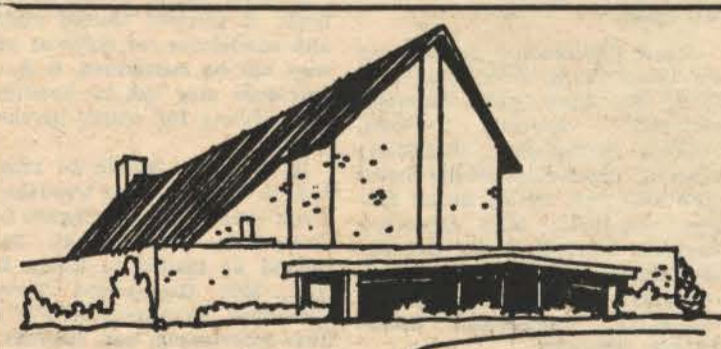

# ABSENT BUSINESS OWNERS MISS OUT ON CENTER UPDATE PLANS

Distinguished by a complete absence of Center businessmen, the latest in a series of public meetings on a Maryland-National Capital Park and Planning Commission proposal to revitalize the Greenbelt Center Mall shopping area took place on June 16. Dennis Piendak, Assistant City Manager, who chaired the meeting, remarked that although in Greenbelt there is usually no problem in getting people out to a meeting, in this case letters and phone calls had not brought results.

MNCPPC representatives presented the draft of a proposal which contained market analysis, urban design analysis and suggestions for implementation of the plan. The final report was due in mid-July. Comments on the draft were invited; the deadline for comments, which may be made to the city staff or directly to MNCPPC, was June 30. No comments had been received earlier on the market analysis, which was presented at an April meeting. The MNCPPC staff present at the meeting emphasized that the city, building owner George Christacos and the businessmen in the center would have to cooperate in order to implement the plan. All acknowledged that such cooperation may be difficult to achieve.

In commenting on the lack of attendance by the business people, Leo Gerton, former owner of High's expressed pessimism about the prospect of getting the three interested groups together. He suggested that perhaps the rationale behind the proposed revitalization — the expected decrease in the Center's business from increased competition from new shopping centers — had proved incorrect.

## Business Falling Off?

No one present could either confirm or deny that business in the Center had fallen off. Sergio Rodriguez, MNCPPC representative, pointed out that once a decrease occurs, it may be too late to do anything about it.

Joe Valenza MNCPPC economist who made the market survey of Greenbelt, pointed out that his findings indicate that the pinch on Center businesses will indeed come, if it has not already occurred. He stated that Greenbelt's surroundings have changed and the level of competition has increased dramatically. In the secondary market area (the area outside old Greenbelt) the amount of commercial floor space equals that in Landover Mall. For this reason the Center market will continue to fragment. Valenza urged that steps be taken now to prevent the customers from being attracted away, pointing out that prevention will cost less than an attempt to get customers back.

George Christacos, owner of the buildings in the Center and the land on which they are built, demurred somewhat at this analysis, stating that, in his experience, competition is always for the best — it stimulates traffic and may actually improve business. He went on to say that he has a plan to improve the property and will do so eventually.

Christacos and others at the meeting appeared to be impressed as MNCPPC staff member Robert Cline showed drawings of the renovated Center with upgrad-

ed facades, new signs, improved traffic patterns and a solution to the problem of delivery trucks which are too long for the Centerway parking spaces. As was the case in an earlier meeting, an indoor/outdoor rooftop restaurant proposed for the space above the Greenbelt Variety, the barbershop and beauty salon drew the most favorable comment.

Christacos emphasized that the city is now "in the middle." It must take some actions to alleviate parking problems before any other action can be taken. He stated that he is ready to move on making improvements but that parking problems must be solved first.

MNCPPC staff member Sylvia Silverman discussed various possible methods of financing the improvements. She suggested that formation of a Local Development Corporation might be the most feasible solution. Such an LDC could take advantage of low interest loans currently available from state and federal programs designed to aid communities in efforts such as the proposed revitalization. Bladensburg has formed an LDC and it was suggested that some discussion with persons involved in the Bladensburg renovation would be helpful.

The next public meeting will be August 14 at 8 p.m. to discuss the final MNCPPC report.

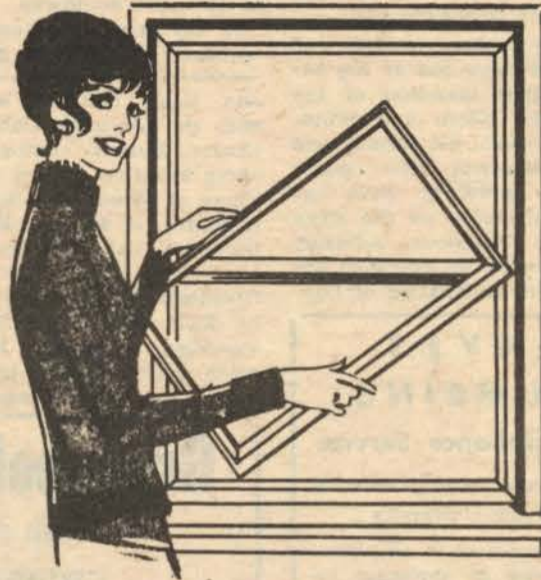

## NOTICE OF CHARTER AMENDMENT



At its regular meeting of July 13, 1981, the City Council of Greenbelt, Maryland, adopted Charter Amendment Resolution Number 1981-3 (Resolution No. 488); and the following Title of the Resolution is a fair summary of the amendment:

### CHARTER AMENDMENT RESOLUTION NUMBER 1981-3

RESOLUTION OF THE CITY OF GREENBELT ADOPTED PURSUANT TO THE AUTHORITY OF ARTICLE 11E OF THE CONSTITUTION OF MARYLAND AND SECTION 13 OF ARTICLE 23A OF THE ANNOTATED CODE OF MARYLAND (1957 EDITION AS AMENDED), TITLE "CORPORATION-MUNICIPAL," SUBTITLE "HOME RULE," TO AMEND THE CHARTER OF THE CITY OF GREENBELT, SAID CHARTER BEING SUBTITLE 40 OF ARTICLE 17 OF THE CODE OF PUBLIC LOCAL LAWS OF MARYLAND (1963 EDITION AS AMENDED) AND CONTAINING IN WHOLE OR IN PART THE CHARTER OF THE CITY OF GREENBELT, BY REPEALING AND REENACTING WITH AMENDMENTS SECTION 4, TITLE "CREATION; QUALIFICATIONS; COMPENSATION" TO PROVIDE A SALARY OF \$3,400 PER ANNUM FOR THE MAYOR AND \$3,000 FOR EACH OF THE OTHER MEMBERS OF COUNCIL

The above Charter amendment shall become and be considered a part of the Charter of the City of Greenbelt, Maryland, according to the terms of the amendment, in all respects to be effective and observed as such, upon the 21st day of September, 1981 (the beginning of the new term of the City Council to be elected September 15, 1981), unless on or before the fortieth day after passage, which shall be the 22nd day of August, 1981, there shall be presented to the Council of the City of Greenbelt, Maryland, or mailed to it by registered mail, a petition for referendum signed by twenty percent or more of the persons qualified to vote in the regular election of the City of Greenbelt, requesting that the above Charter amendment be submitted on referendum to the voters of the City of Greenbelt.

A copy of the above Charter Amendment Resolution is posted in the Greenbelt Municipal Building in accordance with the requirements of Section 13(d) of Article 23A of the Annotated Code of Maryland, and may be obtained from the City Clerk, 25 Crescent Road, Greenbelt, Maryland - Telephone 474-3870 or 474-8000.

- Retention of North End School as a community facility.
- Implementation of "Staying Alive" drug prevention/intervention program.
- Full funding for Greenbelt CARES.
