Council Hears Plan for Music-Video-Restaurant Facility in Beltway Plaza

The traffic and parking situation at Beltway Plaza could be affected by two proposals that were reported to the Greenbelt city council at its January 27 meeting. City Solicitor Robert Manzi reported on the details of the proposed music video establishment, and county councilmember Richard Castaldi advised the city council of a bill before the county council that would allow large shopping centers to expand without increasing parking.

The Copa

Manzi reported on the hearing before the county liquor board on January 23. Norman Gross is applying for a BLX (luxury restaurant) liquor license for a music video establishment called the Copa. The liquor board deferred a decision until its March 27 meeting to allow the city to meet with Gross and then to express its concerns to the board. The council will meet with Gross on Wednesday, February 12 at 8 p.m.

According to Manzi, Gross is the owner of the Annie's and Numbers nightclubs in Washington as well as of the Fitchcock and Brown restaurant in the old Post Office Pavilion. While there is a Copa operation in Virginia, Gross says that that operation is primarily a lounge and is not what is planned for Greenbelt.

The Greenbelt Copa will be located at the site of the present two-theater Showcase — Beltway

complex, according to Manzi, not the six-theater Academy-6 site as previously thought by the council and staff. The 9,750 square foot establishment will include a 154-seat restaurant on two floors (ground and balcony) and a sizable dance floor. Manzi said the dance floor would be at least 40 feet long; while unsure of the exact dimensions, he thought it was about 20 by 40 feet. There will be a 50-foot screen on one wall.

Manzi described the interior as dark, with a square bar separating the dance floor from the restaurant, and with two service bars on the sides of the dance floor. According to Manzi, it is "not a tavern-type atmosphere."

Manzi was told the Copa restaurant will be open from 5 p.m. to 10:30 or 11 p.m. with the night club open until midnight, 2 and 3 a.m. on different nights, as allowed by the liquor board. All entering will be carded with no one under 21 allowed unless accompanied by an adult or going to the restaurant. There will be a dress code.

According to Manzi, Gross indicated a willingness to abide by the Virginia Alcoholic Beverage Control Board's rules on what can and can't be shown on the screen. (Prince Georges County apparently has no such rules at this

time.) During the dinner hour—roughly 5:30 to 8:30—more "low-key" entertainment will be shown.

Manzi also said that Gross suggested the facility could be used for other purposes during the day. He mentioned senior citizen programs, sports, and a possible Saturday morning cartoon program under a registered day care operator.

BLX Licensing Requirements

In response to a question from councilmember Antoinette M. Bram, Manzi summarized the law regulating BLX licensing. The law establishes certain requirements for restaurants receiving a BLX license, including cloth napkins and quality beef, fish and fowl entrees. If entertainment is provided, it is supposed to be along the lines of that provided by fine restaurants.

In addition, an expenditure of \$500,000 on amenities is required, not including the land and building. Manzi said Gross cited costs of \$75,000 for the kitchen, \$100,000 for the dining room, \$250,000 to purchase the theater fixtures—some of which will be usable for the new operation—and \$100,000 for audio-visual equipment, for a total of \$525,000.

Possible Sites for Police Station Increased to 15

Instead of narrowing the list of prospective sites for the new police facility, the city council has expanded the number under consideration to 15. Because so many sites are under consideration, the city is holding a public hearing on February 18. The city staff will provide a brief analysis of the pros and cons on each location.

The 15 sites to be presented at the public hearing include the following:

- 1) Parcel 8 north of Crescent Road between Kenilworth Ave. and Ridge Rd.;
- 2) A portion of Parcel 7 near the northeast corner of Crescent Rd. and Ridge Rd.;
- 3) The old PEPCO substation property and city park land on Crescent Rd. at Greenhill;
- 4) City land between the Fire Station and St. Hugh's rectory;
- 5) The GDC property at the southwest corner of Parkway and Crescent Roads;
- 6) Vicinity of Greenbelt Armory;
- 7) Greenbelt Municipal Build-

ing (the city offices to be relocated);

8) A new building wrapped around the Greenbelt Municipal Building;

9) The Roosevelt Center parking lot adjacent to the Post Office and adjacent to the Candy Cane City area;

10) Greenbelt National Park property;

11) The State Highway Administration's District Engineer's Office;

12) Center School in exchange for North End School;

13) State Highway Administration interchange property on the Golden Triangle next to the new PEPCO substation;

14) Parcel 15 on Greenbelt Rd. between the Beltway and American Legion;

15) Witt property at southeast corner of Hanover Parkway and Greenway Center Drive.

Criteria under consideration for an efficient police facility include size (two acres would be ideal), topography (is a site too steep and expensive to level?), land use restrictions, estimated cost and access to major roads.

Tax Relief For S&L Depositors

The Internal Revenue Service ruled on January 29 that taxes do not have to be paid this year on interest that was earned but could not be withdrawn from Maryland savings and loans. Taxes will be due for the year in which the money is released. The State of Maryland will follow the same rules as the IRS with respect to these deposits.

Taxes must be paid on any interest that was withdrawn during the year. For example, a depositor who earned \$1,000 during 1985 and had a year-end balance of at least \$1,000 would not be required to report interest for 1985. If the year-end balance is \$800, taxes would be due on \$200.

Due to the late ruling, the affected savings and loans have until February 28 to mail the "1099" forms telling depositors the interest earned. Anyone who needs that information earlier may call Community at 493-6555.

In addition, Community Savings and Loan has received permission to allow depositors to transfer funds from a frozen account to newly created individual retirement accounts. Restrictions do apply. Community has mailed notification of this policy to depositors. Anyone needing additional information should contact Community at 493-6555.

Center Plans Continue; Charette Finale Planned

Plans to renovate the Roosevelt Center rolled forward at the Greenbelt city council regular meeting on January 27. Council voted four-to-one to sponsor the Charette Finale which will formalize a design plan for the Roosevelt Center.

At a work session on January 14, council discussed establishing two teams to develop a master plan. The design team would draft a plan based on information provided by council and the original charette effort, and a resource team would be available to answer questions and provide information. The two teams participating will incorporate the four designs generated by the Greenbelt Charette on June 2, 1985.

"Change is going to take place," councilmember Ed Putens said, "and it will be better if we have complete guidelines to offer the owner."

Mayor pro tem Thomas White opposed the idea because he said the citizens did not have enough say in the design.

History of the Greenbelt Charette

The proposal for a design project, called a charette, to rehabilitate the Center was presented by Norene Yoch last February. "Charette" is a French term for a cart which rolled down the middle of a drawing laboratory collecting student designs. A charette is usually conducted within a time frame of two hours or two days. After the drawings are collected, a jury reaches a

conclusion on the final design.

In preparation for the charette, surveys were conducted at the end of April to establish the needs and wants of residents and merchants. The results were presented to the design teams for consideration. According to the surveys, the least attractive part of the Center was the store fronts and the most frequent suggestion for making the Center more attractive was to add a restaurant.

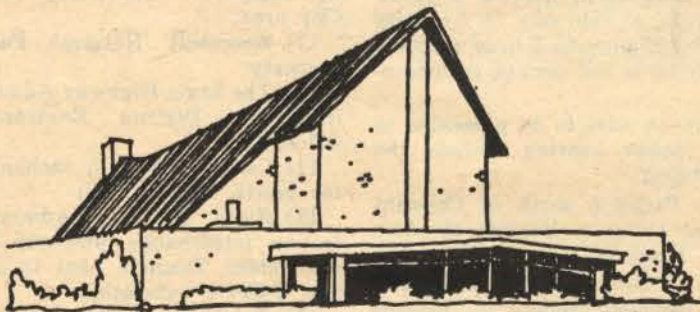

Washington's Birthday Marathon, February 16

On Sunday, February 16 at 10:30 a.m., the 25th Annual Washington's Birthday Marathon (26.2 miles) will be held starting at the NASA Recreation Center just off Soil Conservation Road. This is the oldest marathon in the Washington-Baltimore area and was first held in February 1962. The three runners who dominated this marathon and were prominent in long-distance running in D.C. Road Running races in that era will be there. The winner of the first marathon was Dick Haines who won in 2:32:44 in 1962, and again in 1964 in almost the same time in 2:32:40. Lou Castagnola, the only runner to win this marathon three times, won in 1963, 1967 and 1968. Bob Scharf won in 1965 and 1966. In the 1966 race Scharf won over the Canadian Ron Wallingford by one second in 2:25:01 in the first marathon in Beltsville. Castagnola held the best time of the three runners with his 1967 win in 2:22:45. The present record for this marathon is 2:22:14 by Bobby Doyle of Rhode Island in 1978.

The best place to see this marathon is at Soil Conservation Road and Beaver Dam Road as the runners come by at that point three times and have only the two miles going back to the finish. There is parking available a short distance away on Beaver Dam Road.

There is no registration for the race on race day. Runners

may pick up entries at both Greenbelt recreation centers or call 474-9362 for late entries. This is a certified course with runners' times accepted at Boston.

Vote on Indemnification of Officers And Employees Passed GHI Members

At a special membership meeting of Greenbelt Homes, Inc. on January 21, the membership approved both substantive and editorial amendments to the bylaws, the rules by which the corporation is run. Among changes adopted were provisions permitting multiple year contracts, requiring residency to hold office in GHI, allowing the membership to request voting by secret ballot at general membership meetings, and a new article to provide for indemnification of elected officials and employees. On a motion from Audit Committee Member Chuck Hess, the majority of the amendments were passed unanimously, without discussion, as submitted by the Adhoc Bylaws Review Committee.

The bylaws committee, chaired by Steve Polaschik, had met over the past year and developed the recommended changes. Earlier attempts to meet, discuss and approve the changes were not successful. The annual meeting last May was adjourned before the amendments could be considered. There was not a quorum at the special meeting called on October 22. Although attendance was only slightly higher at the January 21 meeting (44 voting cards were issued), under State law voting on the bylaws could take place at this second meeting, regardless of whether or not there is a quorum.

Indemnification

The indemnification provision prompted a good deal of discussion among the members. The provision protects former and current directors and officers or employees of the corporation against claims and liabilities resulting from their work for the corporation. With the passage of this article, the corporation may pay for necessary legal expenses for defense and judgment in cases where an employee or officer being sued had acted in good faith. The board of directors, by a majority vote of a quorum which consists of directors who were not parties to the suit, or legal council, will determine whether individuals acted in good faith and in the best interest of the corporation. Without the assurance of this protection, it was felt that it would be difficult to have members run for the Board or to hire management staff and other employees.

Steve Curtis suggested an amendment to the indemnification provision, which was discussed at length but finally rejected. He proposed that all officers of the corporation sign a statement that he or she has read the bylaws

and the mutual ownership contract and has signed a conflict of interest statement. While there was a good deal of support for this approach, it was finally decided that these requirements could be better handled under procedures dealing with training and orientation for Board members and new employees.

Corporation attorney Patrick Clancy added that generally in legal proceedings it would be assumed that officers of a corporation were knowledgeable about its basic documents and policies.

The indemnification provision, as finally adopted, covers board members and officers, members of elected committees (i.e., Audit and Nominations and Elections Committees), and employees.

Contracts

Changes were made in the amendment to permit multiple-year contracts. Voicing a concern about the total commitment of funds in these contracts, Steve Curtis proposed that an overall limit be set for this type of contract. Eventually, a \$200,000 maximum was set as the outstanding balance on multiple-year contracts at any one time.

In response to a member's question, management replied that currently the only contracts they plan to let under this provision would be those for tree trimming and copier rental, where a much more favorable rate can be obtained if the contract runs for several years rather than a single year.

New Voter Registration Forms Are Available

The new statewide voter registration forms are now available at offices of the State Motor Vehicle Administration, State Social Services Administration, and the State Department of Health and Human Resources. A citizen who obtains the form submits it to the local election board for the county in which he lives.

Persons are qualified to register to vote in Maryland if they are citizens of the United States, at least 18 years old by the next general election, a legal resident of Maryland who has not been convicted without a pardon more than once of an infamous crime or currently under sentence for conviction of an infamous crime nor under guardianship for mental disability.

Since applications must be received approximately five weeks prior to an election they should be secured in a timely manner. Applications received on time will be processed and if the applicant is qualified a voter notification card will be sent to the individual. Only voters affiliated with one of the major political parties, Democratic or Republican, may vote in the primary election of their party, but all voters may vote in a general election or in a Board of Education or other nonpartisan primary.

New Passenger Cars Put On MARC/Amtrak Route

The Maryland Rail Commuter (MARC) Service has recently placed in service 15 new passenger coaches on the Amtrak line between Penn Station in Baltimore and Union Station in Washington as part of a \$27 million program to improve equipment on the line.

The cars, which seat an average of 110 passengers each, feature comfortable, high-backed seats, special seating accommodations for the elderly and handicapped, luggage racks, a public address system, and other amenities for the comfort of commuters.

The purchase of the cars was funded 80 percent by the federal Urban Mass Transportation Administration and 20 percent by the state.

What is a P P O?

PPO stands for Preferred Provider Organization. It refers to a number of groups recently organized by insurance companies in an effort to control the rapidly expanding use of dental insurance. The main objective of a PPO is to enroll dentists who agree to provide dental care at reduced fees to its members. PPO's then negotiate with larger employer groups such as the steel and auto industries as well as government agencies, and provide them with a list of dentists who have agreed to the insurance company's guidelines.

The main objection to PPO's is that they limit a patient's choice of dentist to only those who are enrolled in the plan. This, in fact, means a patient must give up his "freedom of choice" to receive benefits. In addition many examples of insurance fraud and questionable treatment practices have been reported, especially in conjunction with large dental centers.

When selecting a dental insurance plan you should have the right to have your treatment rendered by the dentist of your choice. Most insurance plans allow the option of going to a participating or non-participating dentist. Although a non-participating dentist has no agreement with the insurance company, you can still be reimbursed directly from the company. PPO's do not have this option. Several states have passed "freedom of choice" legislation to protect the dental consumer from this unfair practice. Many other states have similar legislation pending.

Water Main Modernization Slated to Begin in March

The Washington Suburban Sanitary Commission will conduct a Water System Modernization Project to bring water mains up to modern standards in the Greenbelt and College Park areas. Starting in March, the four-month program will include the area along Ridge Road, from 150 feet east of Lastner Lane to Eastway.

Designed to improve customer service and fire protection, the reconstruction operation will involve cleaning and lining existing water mains to restore their carrying capacity. Accumulated corrosion in the pipes will be eliminated by means of a powerized cutting tool. Then the pipes' interior surfaces will be coated with a thin mortar lining to protect against future corrosion.

According to WSSC Bureau of Maintenance Director Cortez A. White, "The process to be used this year will completely ream the existing pipe and provide it with the corrosion-controlling liner, which is a standard feature of today's new ductile iron water mains in suburban Maryland." The procedures, he noted, has already been used with "success."

With isolated exceptions, the modernization process will not require the extensive and disruptive excavation work which would occur if mains were dug up and replaced. However, temporary inconvenience to traffic and to some individual customers can be expected. Since there is no access to water lines through manholes, water pipes which are four to six feet underground, must be reached by means of digging.

"Every effort will be made to coordinate project activities to minimize problems," said White. He explained that where mains are being cleaned and relined, "existing connections from the pipeline to customer units will be disconnected from the main and reconnected to temporary water service lines so that customer water service will be maintained while the work is in progress."

Temporary pipelines will be placed on top of the ground. This work will only be scheduled when temperatures are above freezing to prevent icing conditions.

All work will be done by WSSC contractors under WSSC's supervisory inspection. The bidding process is underway.

Expected to cost about \$490,000, the project is being handled as a general WSSC system im-

City Offers Elderly Rental Assistance

The City of Greenbelt offers grants to Greenbelt renters amounting to 3% of the rent paid during the preceding year for a dwelling in the city.

To be eligible, a renter must be at least 65 years old or be totally and permanently disabled if under 65: The combined gross income of the applicant and all other persons within the household shall not exceed \$5,000 for the preceding calendar year. The applicant must reside within the city at the time of making application, as well as having paid rent for a dwelling in the city.

Applications may be filed until February 15, 1986, for assistance for the grant year 1985. Applications are available from the City Treasurer's Office, 25 Crescent Road. It is not necessary to apply in person. Residents may call the Treasurer's Office at 474-1552 and request that an application be mailed to them.

Both the State and Prince Georges County offer similar programs. Information about the county program can be obtained by calling 952-3770. Those wishing information about the state program should call 1-800-492-3790.

and Bram questioned the inclusion of the last two expenditures, since they are entertainment oriented. Manzi concurred, stating that his interpretation of the law is that the expenditure is supposed to be used to give the interior an "aura of gentility."

White and Bram were also concerned about possible loitering. Bram said she'd been told that there are "always" long lines outside Annie's. Manzi reported that the original theater lobby would be retained, so that the lines would be inside, and that the lease with Beltway Plaza would prohibit people's gathering outside. White was skeptical, saying that the center is "designed" for loitering, that the Golden Dome "encourages it" and that the Copa would be a "further inducement."

A major question is how the liquor board will interpret what is a luxury restaurant and appropriate entertainment. City Manager James K. Giese noted that Prince Georges County does not have either a "nightclub" or a "tavern" license, so that all liquor served is in conjunction with some form of restaurant. Giese said it is not clear when an establishment becomes a nightclub rather than a restaurant.

In a conversation with the News Review, liquor board commissioner and chairman Robert S. Miller said he had "varying degrees of satisfaction" with the nature of the various BLX establishments in the county. Miller said the board is doing a study of all the BLX establishments in the county and that the Maryland General Assembly has given the board wide discretion to issue regulations relating to these licenses.

At an earlier meeting, the city council questioned whether the \$500,000 expenditure requirement should be raised to reflect current costs. Miller says this requirement has been raised and lowered several times (from \$250,000 to \$500,000 to \$300,000 and back to \$500,000), but he does not know if the Maryland General Assembly would consider raising it. He did say that while the board has discussed raising the limit, there are no proposals pending.

Less Parking Needed?

County councilmember Castaldi presented the city council with details and history of the proposed legislation CB-3-1986, which would reduce the required parking area for any large (more than 400,000 square feet) shopping center by twenty percent. The only such center in Greenbelt is Beltway Plaza.

The bill originally related only to those shopping centers within 1500 feet of a Metro station, but was revised in committee to refer to all large centers. Castaldi said members of the committee reviewing the bill cited an as yet unreleased report by the Urban Land Institute that finds that currently too much parking is required for the larger centers. from the county council referred to a report by Robert Manzi, serving as attorney for Prince Georges Plaza. According to this material, Manzi said that a week-long survey of the P.G. Plaza in May showed more than 1,000 unused parking spaces each day between 1 and 2 p.m. The survey period included the Memorial Day weekend.

Mayor Gil Weidenfeld said the bill does not recognize that there may be existing shopping centers, such as Beltway Plaza, with barely adequate parking. He suggested that the shopping centers be required to document that they have excess parking.

Castaldi said parking lots and the parking code are never planned for peak periods such as Christmas; that planners try to find an average. He said a study might find sufficient parking, although some spaces may not be convenient.

Castaldi said the bill has strong support and that it is important that the city make its case if it disagrees. He said that with the deletion of the Metro references it is a much "tighter" bill and will be difficult to defeat.

A public hearing on the bill will be held Tuesday, February 11 at 1:30 p.m. before the county council in Upper Marlboro.

City Council Juggles Future Planning With Some Planning for the Future

The Greenbelt city council dealt with the future at its January 27 meeting, discussing long-range planning and zoning, and approving a position description for a city planner.

After a cable-related delay as the cable technicians strive to turn council a lighter shade of green, the council dealt with a future look backwards, approving a meeting for Monday, February 10 at 7:30 p.m. with Dorothy Sucher and the museum subcommittee of the fiftieth anniversary committee. The possible purchase of a residence for the museum will be discussed.

At the suggestion of Mayor pro tem Thomas X. White, the city staff will inquire of the Greenbelt Homes Inc. (GHI) whether they have any concerns about the use of a GHI home for the museum.

Legislative Conference

White reported that the Maryland Municipal League has selected Greenbelt as the site for its 1987 legislative conference. The city sought this conference to tie in with the city's fiftieth anniversary celebration.

Mayor Gil Weidenfeld suggested that the staff draft a proposal for an "exciting conference." Council directed the staff to invite the Prince Georges Municipal Association and the county government to participate in planning the conference.

Council also approved, with some tinkering, a job description for a city "planning and development coordinator." This person, to be a fulltime employee, will deal with planning and development issues, act as the staff's liaison with the city's Advisory Planning Board (APB), and administer the street permit program.

White was concerned that certain phrases could result in the planner's being detailed to day-to-day operations rather than concentrating on planning and development issues. Weidenfeld, however, said that because the city has a small staff, the city manager needs some flexibility in staff assignments.

After the job description was approved, City Manager James K. Giese reported that he had a "tentative employment understanding" with someone, and that he "would caution council to watch their genders."

Long-Range Planning Report

APB has also been looking at the city's planning needs and council unanimously approved their report (number 382) on long-range planning.

In the report, APB said that until council establishes guidelines and directions and identifies the problems to be reviewed, it would be premature to establish a new long-range planning committee.

In the report the board recognized the need for a more "proactive" rather than "reactive" approach to planning. In order to address these needs, APB now meets twice monthly, with one meeting devoted to future planning. It has identified some topics to discuss—Greenbelt East, Roosevelt Center, Beltway Plaza, the Metro station and Springhill Lake, North End School, a trails plan and several others. The board did warn that long-range planning requires more information and time than is needed for development review.

Rezoning Request

The council accepted, for future discussion, APB report number 384 on a rezoning request. The request deals with two small parcels (2.84 acres combined), located behind the Shell station on Greenbelt Road near Cipriano Road. The land is currently zoned for residential purposes and rezoning to commercial-office (C-O) is requested.

APB recommends approval of the application since the master plan indicates commercial use and, because of the small size of the parcels and access problems, the land is ill-suited for residential use.

However, APB recommends that the city's approval be conditioned on the city's receiving site-plan, landscape plan, and sign plan review, together with a proviso that no buildings of more than three stories be erected on the property. In addition, the access problems must be resolved.

White asked Giese to find out what master plan this parcel is

in, saying that since the Greenbelt-College Park-Langley Park master plan is under review, that could affect his thinking.

Youth Center Use

At council's request, the city's Parks and Recreation Advisory Board (PRAB) investigated the use of the Youth Center by the Adult Coffee Hour. In its report (number 1-86), PRAB recommended that the recreation director "should continue to provide space to this group appropriate to its size" at the Youth Center. The group's organizer, Irene Hensel, had spoken at a previous council meeting objecting to their assignment to a basement meeting room.

On a motion by councilmember Antoinette M. Bram, the council supported PRAB's position, but deleted the phrase "appropriate to its size."

Council approved for second reading and final passage the transfer of funds for various street improvements including the widening of Hanover Parkway and Mandan Road and the installation of a storm drain on Maplewood Court.

Del. Devlin Files Bill

Supporting Driver Ed

Delegate Gerard F. Devlin (D-PG) has introduced legislation to extend State Assistance for local driver education programs for an additional five years. Unless the General Assembly acts during the present session, the program, under which the State pays \$45 for each high school student taking a driver education program, will end July 1, 1986.

"Today, more than ever, we need driver awareness," Devlin said. "We need to educate young people on the technical parts of driving, but also we need to make them aware of the social responsibility that goes with a driver's license."

Moryadas Named Director Of Maryland Realtors

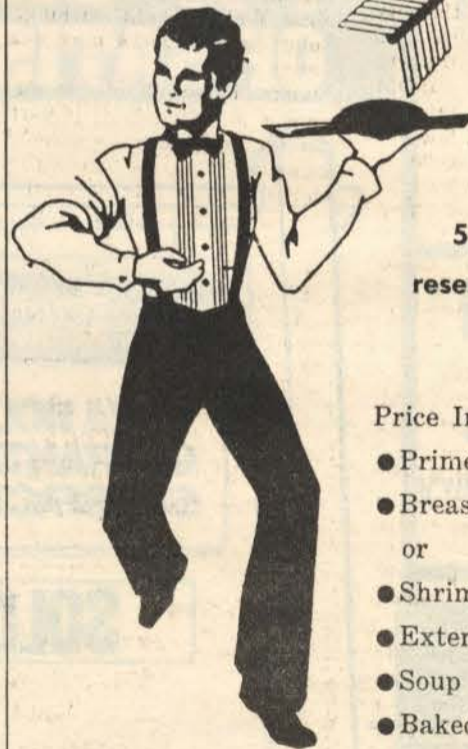
