## Council at Work Session Explores Role of City in Support of Arts

At a recent city council work session, cultural arts advocates urged the council to adopt an arts policy that would promote and accommodate the full expression of the arts in Greenbelt. Representatives of both the visual and performing arts attended the August 31 work session to seek support for permanent facilities.

A Parks and Recreation Advisory Board (PRAB) report accepted by council on August 24 provided much of the context for discussion at the meeting. In the report, PRAB chairman Keith Chernikoff reminded council of an earlier board recommendation that the cultural arts policy of the city be studied before committing funds to the Greenbelt Arts Center or the Utopia Theater on a long-term basis. Included in the report were recommendations to resolve outstanding issues concerning the city's role in funding the arts.

Members of the arts community stated early in the meeting that they want a performing arts center at the Roosevelt Center and a visual arts center at the North

End school. However, attention at the work session focused on PRAB's recommendation for a task force to develop an arts policy that could address such goals.

### Task Force Structure

Two contrasting ideas for the form of such a task force surfaced at the meeting: 1) an independent committee, whose findings and recommendations are reported directly to the city council; 2) a subcommittee of PRAB, whose findings and recommendations go through PRAB before going to council.

Mayor Weidenfeld explained that the PRAB subcommittee option was the more practical approach. He pointed out that an independent body required the individual appointment of all members by the city council - a process that could not begin until a resolution establishing such a body was passed and all position openings properly advertised. According to Weidenfeld, PRAB could recruit people for the proposed task much faster, since it is a standing advisory board with authority to organize subcommittees. In addition, Weidenfeld said that the PRAB subcommittee approach supplied needed expertise in communicating technical information to council. Isaacs added that PRAB was made up of

people with a proven concern for Greenbelt's welfare, who desired a part in developing the city's arts policy.

People closely identified with the arts disagreed with this approach. Konrad Herling, vice president of the Greenbelt Arts Center, said he feared too much control by PRAB over the outcome of the policy-making process. Albert Herling also disagreed with the approach, saying it gave PRAB the right to veto the proposals of the committee. Herling, a long-time supporter of the arts in Greenbelt, is on the Board of Trustees of the Prince Georges Arts Council. Councilmember Toni Bram said the PRAB subcommittee approach would water down the overall effort.

Although a consensus was never reached on the type of committee for creating an arts policy, agreement did emerge as to who should serve on it. City Manager James K. Giese noted that any adopted policy entailing city funding must inevitably compete with other programs. He said a financial commitment by the city to such a policy over the long-run needed a broad base of citizen support. Because of this consideration, arts supporter Barbara Simon accepted the idea of a task

## Council Approves Plan for Parcel 15

At its August 24 regular meeting, the Greenbelt City Council accepted the Advisory Planning Board report on the Roosevelt Center, approved development plans for Parcel 15 near the lake park and agreed to modifications to the improvements the Greenbrook developer is required to make to Hanover Parkway.

### Board Reports

Council accepted the Advisory Planning Board's report on the parking and circulation designs for the Roosevelt Center proposed by landscape architects Coffin and Coffin. APB recommended approval of the plan placing the traffic islands in the east and west parking lots in an east-west alignment rather than the current north-south alignment to minimize pedestrian/vehicle conflicts. The plan also would replace the angled parking with straight-in parking, and allow two-way traffic in the parking lanes. The report will be on the agenda of the October 5 regular council meeting. The September council meeting was cancelled.

Council also accepted the Parks and Recreation Advisory Board's report on Arts Policy Development, which recommends establishment of a task force. This group would propose strategies to: (1) enrich the lives of

the citizens by providing the opportunity to learn about, participate in and observe the arts; (2) provide a variety of programs in all fields of the arts; (3) establish a visual arts center at the North End Center and (4) support an arts center at the Roosevelt Center. This report was discussed at an August 31 council work session and will be on the agenda for the October council meeting.

### Strategic Planning

Council received a written report from the Strategic Planning Coordinating Committee on the goals and objectives identified by the strategic planning subcommittee. The coordinating committee has directed the subcommittees to better define and schedule the steps necessary to achieve the objectives. This work is to be completed by September 30.

### Legislation

Final approval was given to legislation that will:

- Change the penalties charged for past-due taxes to equal those charged by the county, beginning with next year's billings, since the county will assume the responsibility for municipal tax collection. The penalty on real property taxes was decreased from one to three-quarters percent per month, while that for personal property taxes was set at three-quarters percent per month versus a flat charge of five percent currently charged by the city.

- Establish a Roadside Cleaning Crew to be financed by a portion of the landfill tipping fee rebate.

### Bicycle Traffic

Council member Joseph Isaacs reported observing an incident where members of a metropolitan area bicycle club ran a stop sign on Lastner Lane at Ivy Lane, nearly striking a child. Isaacs said that the offending rider, without stopping, responded by yelling at the child's father. Isaacs estimated that the bicyclists were traveling approximately 40 miles per hour. He requested that the police patrol

## New Council is Sworn In

Greenbelt's five re-elected officials pledged to fulfill their duties of office at the first meeting of the new council Monday, Sept. 21.

A packed council chamber audience watched the council quickly organize itself according to the election results of the preceding week. Acting as the incumbent mayor at the outset of the meeting, Gil Weidenfeld administered the oath of office to the newly elected council members. Because Weidenfeld finished first in the election, he was voted in by council as the new mayor. He was then sworn in by the county circuit court clerk Norman Pritchett. The council also voted in Joseph Isaacs as the mayor pro tem because of his second place finish in the elections.

The swearing-in ceremony was part of a larger celebration that night. The city government's staff hosted a reception to honor the new council and to commemorate the 50th anniversary of the council manager form of government in Greenbelt. A buffet and bar, set up by the Ladies Auxiliary to the Fire Department, and fire department members, helped set the tone of celebration. Among

## Public Hearing Next Week on Planning Bills

Two bills pertaining to planning and development are currently under consideration by the Prince Georges County Council. One, CB114 (also known as the Adequate Public Facilities Bill) would require that before a proposed development can be approved, public facilities adequate to serve the development must be in place or scheduled. This bill was proposed by County Councilman Richard Castaldi, former Mayor of Greenbelt. A public hearing for CB114 is scheduled for October 5 at 8:30 a.m. at the County Administration Building in Upper Marlboro.

The second bill, CB104, would prohibit the inclusion into the official record of remarks made at public hearings. Thus, oral comments and statements from principals involved in those cases, as well as oral comments and responses from Council members, would not be available for use in appeals or for court proceedings. A public hearing for CB104 is scheduled for October 6 at 1:30 p.m.

the guests of the council and city attending the night's events were Congressman Steny Hoyer, County Executive Parris Glendening, County Council member Richard Castaldi, State Senator Leo Green, and State Delegate Charles "Buzz" Ryan.

Each of the council members expressed their hopes for the city - some zeroing in on the next two years while others were a little more futuristic.

Mayor Weidenfeld summarized the main tasks of the city over the next two years. He highlighted the following matters: (1) the completion of the bond issue projects—a new police building, the new indoor pool, the renovation of the outdoor pool, Schrom Hills Park and other park improvements, and parkland acquisition; (2) the rehabilitation of Roosevelt Center; (3) overseeing development within the city; (4) alleviating traffic congestion, particularly in Greenbelt East, and blocking the proposed extension of Kenilworth Avenue to Virginia Manor Road, and (5) pressing for improvements to the Kenilworth Avenue/Greenbelt Road interchange.

Weidenfeld said he looked forward to the next two years with much excitement and enthusiasm "because of the promise of new facilities and programs. I believe that we will see more new city facilities and programs coming to completion in Greenbelt during the next two years than we have seen in the last decade," said the mayor. Addressing the issues of development and traffic congestion, Weidenfeld said the council needed to be firm with developers' requests for increased densities and changes in zoning. He said the council must also press the county executive for promised road improvements.

Weidenfeld said he would soon propose a change in the city's election process to council. Although saying he was not for changing the city charter, he proposed instead that an advisory question be included on voting cards allowing citizens to choose the candidate they wanted for mayor. The council would still vote for the mayor, he said, but it would have citizen input in the matter.

Speaking after Weidenfeld, mayor pro tem Joseph Isaacs responded to the list of issues by

## Museum Guides Meet For Training Session

The Greenbelt Museum at 10-B Crescent Road will open to the public during Homecoming Weekend, October 10. In addition to an original sink for a masonry home and a kitchen counter top, the Friends of the Greenbelt Museum (FOGM) are looking for a number of other items.

These include chenille bedspreads for a single and a double bed, a double mattress, pillows, an original bathroom sink, original cushions for the living room chairs, a shaving mug and brush, table cloths, dollies and a rag rug for the kitchen. In preparation for the opening FOGM board members conducted docent training on Saturday, September 26 for the volunteers who will serve as guides. During the full day session at the Greenbelt Library, Sandra Barnes and Don Volk gave background information on how FOGM came into being and the relationship between FOGM and the Museum. Alan Virta recounted the important names and dates that all guides will need to know. The four most important dates include 1935, when construction first began; 1937, when the first families began to move in; 1952, when the federal government sold Greenbelt; and 1940, when the frame houses were constructed.

Virta suggested that the three most important people among the hundreds who were involved in Greenbelt's early history are Franklin and Eleanor Roosevelt, and Rexford Guy Tugwell who headed the Resettlement Administration and was responsible for building Greenbelt. Among the most important elements that make Greenbelt unique are: being built and operated by the federal government; being a planned community; organizing into cooperatives, which suggested a new way of living; having persons selected to live in Greenbelt. Also important to note are that Greenbelt was controversial from the start (its architectural style thought by some to be unAmerican); and it was an experiment to show private industry how to build efficient, economical housing for low to moderate income persons.

Christina O'Boyle then taught the volunteers some basic techniques of interpretation. This was followed by a tour of the Museum. Approximately 20 people took part in the training.

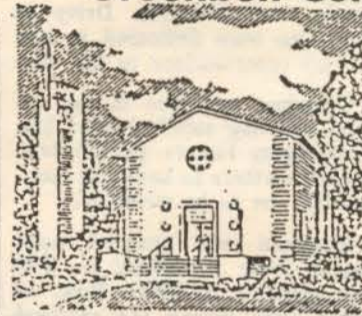

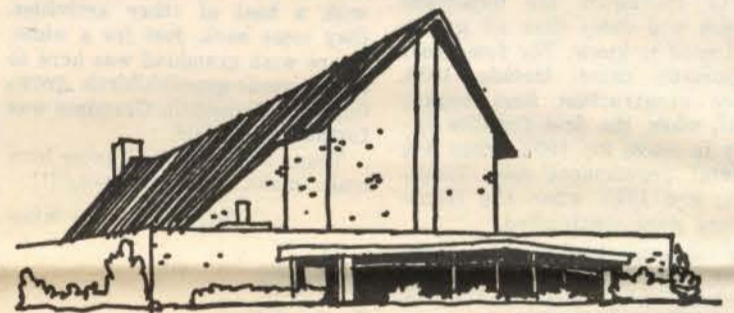

that area to ensure that bikers obey the traffic laws.

Council member Antoinette Bram reported that she had had a request from a Laurel Hill resident that the Research Road gate to the Agricultural Research Center be opened 24 hours a day and provide an alternate route into and out of Greenbelt. However, Bram said that residents of Research Road were opposed to opening the gates because of the increased bicycle traffic this would attract. Bram suggested exploring what legal options the city has to cope with problem cyclists.

Research Road resident Eunice Coxon said the closing of the Research Road gate was "a kindness" to the farm and the city.

## Parcel 15

The preliminary plan of subdivision for Parcel 15, the slice of land between Charlestowne Village and the Beltway, was approved by council. The Milton Company plans to build 98 residential townhouses and 46 office townhouses on the parcel.

APB determined that the plan is consistent with all past city approvals, agreements and understandings and recommended approval.

In response to questions by Bram, Milton Company's attorney Ed Gibbs said that construction equipment would not be permitted on the ten-acre parcel adjoining the lake park that is to be deeded to the city. They will also continue their efforts to get State Highway Administration approval for a traffic light at the intersection of Lakecrest Drive and Greenbelt Road.

Gibbs told council member Edward Putens that the land in the parcel currently used by residents of Charlestowne North Apartments for parking will continue to be so used.

## Other Actions

In other actions the council:

- Approved the request by Porten and Sullivan, developers of a portion of Greenbelt, to modify plans for improvements to Mandan Road because of drainage problems that would result if the road were extended, as required, to the Pepeco right-of-way. Instead, the developer will pave ten fewer feet of road and grade the city's right-of-way to direct stormwater to existing drainage channels. At the suggestion of Bram, council approved the change, but required the developer to place in escrow for seven years, funds equal to the cost of the additional paving.

- Referred the proposed Greenbelt Foundation to the Community Relations Advisory Board for review. The Foundation was recommended by Bram to accept gifts and donations to be used to benefit Greenbelt groups.

force drawn from the community-at-large. However, she said the group had to be strongly represented by arts advocates in order for arts professionals in the community to support it.

## Task Force Purpose

Tom Renahan, vice-chairman of PRAB, clarified the proposed committee's task by dividing it into four parts: 1) To define the city's role in the encouragement and promotion of the arts, the scope of that role, 2) to show how the city's role could best be coordinated organizationally, 3) to show how the needed facilities could be obtained and managed, and 4) to show how funds could be raised to operate programs, and how these funds would be managed. Renahan offered these guidelines for the proposed committee after councilmember, Thomas X. White in particular, sug-

gested that committee work be done in phases to avoid confusion.

White suggested that the task force deal solely with the general objective of outlining the broad policy before handling specific objectives. Councilmember Edward V. J. Putens stressed that public input on all task force pro-

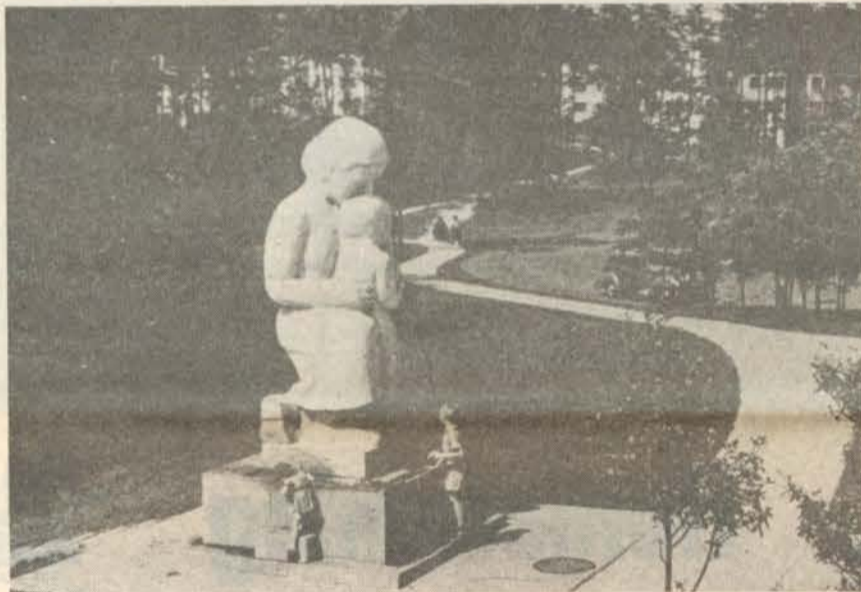

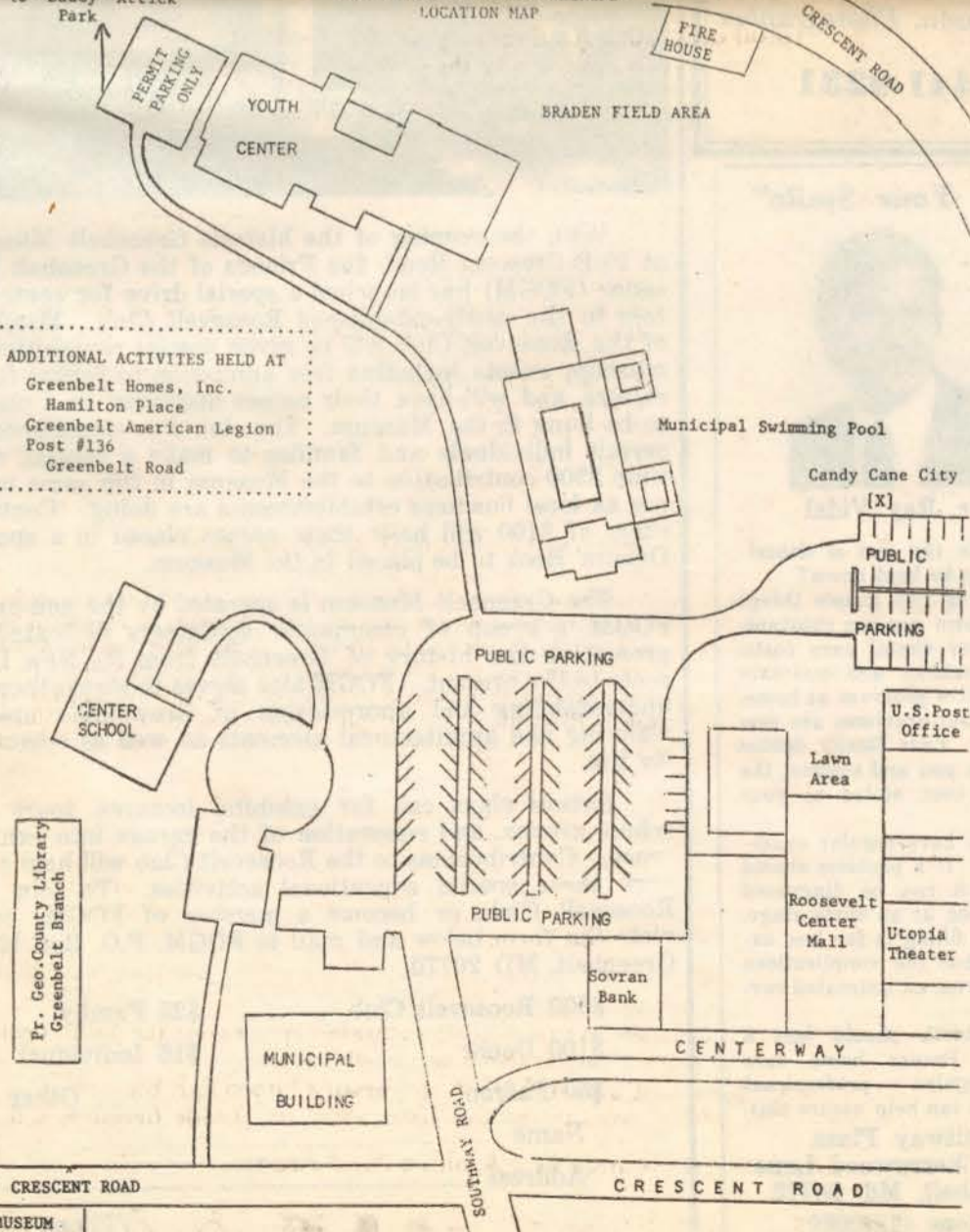

telling the audience plainly that tough decisions lay ahead for the council. Isaacs said he would approach his actions on the council with open eyes and ears and an open heart, "looking at each issue individually and at all facts judiciously"

As with previous speakers, council member Thomas White also addressed the agenda over the next two year. White emphasized however, the council's need to be attuned to the individual needs of Greenbelters. He praised the role of elections in bringing candidates in direct contact with citizens. In his concluding remark, White pointed out that the newly organized council was starting on Greenbelt's next 50 years. "What we do as a council is that important" he added.

Council member Edward Putens addressed two basic challenges

of council deciding which programs and projects to fund, and what to do about taxation. Putens said despite what previous councils have done, there are issues that haven't been dealt with yet such as the needs of senior citizens Putens said he would make sure the council would look into previously unaddressed areas.

Speaking behind her colleagues, council member Antoinette Bram said Greenbelters are fighting for survival against the onslaught of development, and other pressures. She said council would have to make its decisions by putting people ahead of the various places to be dealt with such as traffic and building sites.

The reception at the firehouse was also planned as an opportunity to honor servers on the city's advisory boards who had resigned during the year. Few newly retired board members, however, were on hand to receive certificates of appreciation.

# 50 Years Ago In Greenbelt

Fifty years ago today, the builders of Greenbelt were putting the finishing touches on the new town. Within a few weeks, families would begin moving into their new homes—starting lives built on new dreams. To fully understand the publicity that the new city was getting, current Greenbelters must visit the Tugwell Room of the Greenbelt Library. There, they will find folders filled with original clippings of the many, many news articles that were circulating throughout the country about this bold experiment—Greenbelt.

In mid-September 1937 many of the newspaper articles were concentrating on the cooperative aspects of the new town. Some articles described cooperative activities in the U.S. while a number concentrated on comparing the experiment at Greenbelt to the larger cooperative movement in Europe. Individual writers were producing articles on Greenbelt for local papers and the larger papers and news services such as Associated Press (AP) prepared works that were picked up by large and small papers virtually from coast to coast.

An AP article in the St. Joseph, Md. Press News pointed out the positive aspects of the cooperative movement emphasizing that there were already between 1 and 2 million US members of cooperatives. Figures showed that world wide membership was over 100,000,000 families.

Other articles painted a different picture - one that was to be

repeated: "The development has been criticized as communistic; but if that be the case, then there are thousands who want to go the way that Russia has gone." That quote was part of article documenting the large numbers of families who were applying for residence in Greenbelt.

Advertising Age ran a story entitled "Grocers Fight U.S. Deal with Cooperatives." The National Association of Retail Grocers had filed a protest with the Resettlement Administration over deals made with the cooperative corporation formed by Edward Filene. The Association "emphatically objects to any policy or arrangement under which the government extends to consumer cooperatives advantages it does not . . . extend to other business enterprises."

# POLICE BLOTTER

On Wednesday, September 23 at about 5:30 p.m. a resident man allegedly threatened a process server with a shotgun when the latter came to the man's door attempting to serve civil papers. After the process server left and reported the incident to the Greenbelt police, several officers responded and arrested James Hall, 50, of 167 Westway. The police took 18 guns from the residence for safekeeping. According to the police, there was an active stolen gun report on one of the guns. Hall was charged with theft of the gun and with assault with intent to murder. He was taken to Hyattsville, where he appeared before the District Court Commissioner. He was released on personal recognizance.

On September 19 at 12:54 a.m. officers responded to a report of a person with gunshot wounds in the Beltway Plaza. The victim, who had a minor head wound, said that he had been shot while sitting in front of the Golden Dome Arcade. According to witnesses, police indicated, the gun used was a pellet gun. The area was checked for the suspects and the suspect vehicle, but without result. No description was obtained of the driver of the vehicle; however, the suspect in the passenger seat was described as a white male, in his teens, wearing a white hat with a neck flap.

During a traffic stop on September 18, Officer Steven Keller found that the driver of the vehicle was wanted for burglary by the County Sheriff's Department. Search of the vehicle revealed two baggies of PCP and a machete. The man (of no fixed address) was charged with several motor vehicle violations, possession of a controlled dangerous substance with intent to distribute, carrying a concealed deadly weapon, and maintaining a common nuisance.

One or more persons entered three empty apartments in Springhill Lake sometime during the night of September 23-24 and removed carpeting and a dishwasher. There were no visible signs of a forced entry.

A report of a theft in progress, with a description of the vehicles used by the suspects when leaving the scene, resulted in apprehension of a vehicle matching the description. Officer Michael Jeffreys stopped the vehicle and observed three microwaves in new, factory-sealed cartons inside. When the driver could not verify that he had purchased them, Officer Jeffreys arrested him. Since the victim of the theft could not be contacted, the suspect was released. Later on the same day, September 23, a representative of the construction company reported the theft of three microwaves and was advised to get a warrant for the

suspect.

On September 21 during the day, an apartment on Lakeside Drive was entered and electronic valuables were taken. The apartment was apparently not locked.

The theft was reported at 11:21 p.m. The clerk stated that she had been distracted by one of the four suspects while the theft occurred. All four suspects were described as white male teenagers. A non-resident male was arrested at 4:15 p.m. on September 21 when officers were investigating a complaint of disorderly conduct at a picnic at the rear of the 7700 block of Hanover Parkway. A small seashell pipe, which contained a trace amount of marijuana was found. The man was later released on personal recognizance.

The apartment had been entered by forcing open the kitchen window. Jewelry and a radio/cassette were stolen. The suspects were identified but the victim, who knew the suspects, declined to press charges. The property was returned.

## Serious Accident Results In Massive Traffic Jam

A collision between a car and motorcycle on Tuesday, September 22 on eastbound Greenbelt Road just east of the Baltimore-Washington Parkway caused a rush-hour traffic tie-up which lasted about two hours. The collision involved a motorcycle carrying two persons and an automobile which had exited the outer loop of the Beltway and followed the exit ramp to Greenbelt Road eastbound.

The man and woman on the motorcycle were both injured, the woman more seriously. She was flown by Maryland State Police helicopter to the shock trauma unit at Prince Georges Hospital Center. According to the police report, the woman, who has been identified as Susan Marie McMahon, of 8585 Greenbelt Road, was in critical condition with serious head injuries. At last report, her condition remained unchanged.

According to a police spokesman, the man on the motorcycle was taken by ambulance to AMI Doctor's Hospital in Lanham. The man was identified as David Paul Gorke, 20, of 8585 Greenbelt Road. He has since been discharged from the hospital.

The police report said that neither Gorke nor McMahon was wearing a helmet when the accident occurred.
