Richard Castaldi Drops Candidacy To Attend to Mother's Illness

A front-page story in the Washington Post's Metro section on Saturday, July 16 must have felt like a dousing with cold water to supporters of former Greenbelt Mayor Richard Castaldi in his campaign for Prince Georges County Executive. Based on a press release from the candidate, the article announced his withdrawal from the September primary. In his statement, Castaldi cited his mother's condition, which he described as "critical" following three successive strokes, as forcing his withdrawal.

Castaldi whose three-term tour as county council representative for the 4th district ends this December is a Greenbelt native. In 1981 he was the top vote-getter when he ran for city council. Following Greenbelt tradition, his fellow councilmembers then named him to be the city's mayor or a term left incomplete when he ran successfully for the county council.

Another former mayor Gil Weidenfeld, who succeeded him as mayor and has worked with Castaldi for years in their respective political roles, commented on his friend's withdrawal: "He is one of the most capable among the current members of the county council. His supporters will be very disappointed."

Calling Castaldi "very well qualified" for the post as executive, Weidenfeld said that voters' options will now be more limited. (Weidenfeld himself is running for the county council, all but two of whose members are not eligible for re-election since the term limitation rule was enacted following a citizen referendum in the last election.)

Changing Political Scene

Regional newspapers are filled with speculation about the implications of Castaldi's withdrawal on the race for county executive. Left in the running among the Democrats are long-time incumbent county councilwoman Sue V. Mills, state senator Beatrice Tignor, attorney Wayne K. Curry and civic activist Artie Polk.

Castaldi has not shown his hand concerning which of these candidates he may endorse. Weidenfeld, describing the time as "premature," also will not reveal his personal choice for county executive, now that his long-time associate has withdrawn.

Fund-raiser Event

Castaldi's statement came one day before a long-planned fund-raising party, a barbecue scheduled at the American Legion post in Lanham. Following the newspaper report, however, those with tickets for the event wondered whether they should still turn out. Nevertheless, the former candidate returned to Greenbelt for the occasion, using it as

an opportunity to express appreciation to his campaign team and many supporters for their assistance.

Despite a heavy rain, the occasion was made as festive as possible, with balloons, clowns, face painting and a country Western band. Just before making a personal expression of gratitude to those who had come out to show their support, Castaldi asked the band to repeat a number they had played earlier—"God Have Mercy on the Working Man."

Describing the Depression-era sentiment it expressed as "the real reason I got started in politics," Castaldi said he thought that his talking about the issues he felt were important in this campaign had an impact on the other candidates. In fact, both the Washington Post and the Prince Georges Journal have described his campaign as the most "substantive" of those being conducted.

He said he felt the other candidates had been forced to deal with these issues as well because of his own attention to serious concerns before the county voters. Among those he listed in his press release announcing his withdrawal were managed growth, adequate public facilities, inner-beltway revitalization, neighborhood schools and community policing.

Referring to the reason for his withdrawal, the serious family concerns involving both his elderly parents, he said to the crowd of supporters, "I know in my heart I've done the right thing."

Kangaroo Katie's Site Slated for "Fresh Mex"

Taco Bell has announced plans to open a Chevys Mexican Restaurant in Greenway Center in the former site of Kangaroo Katie's. Chevys is a border cantina style full-service restaurant company acquired last year by Pepsi Co.

This replaces an earlier Pepsi Co. proposal to open an All 'n One restaurant, which was opposed by Greenway Center's owners and the city council. Combined Properties, which manages Greenway Center, welcomed Chevys as "the appropriate use for the site."

The Greenbelt location will be Maryland's first Chevys. Plans call for Chevys to open additional East Coast locations in the Washington metropolitan area, with its first restaurants slated for Greenbelt, Rockville, Annapolis, Pentagon City and several Northern Virginia locations.

Greenbelt Mayor Antoinette Bram lauded the Pepsi Co. for seeking the community's views on how to develop the site.

Council Approves Plan To Put Officer at School

The School Resource Officer Program (SRO) is one step closer to reality following the city council's approach of a concept proposal to permanently station a police officer at Eleanor Roosevelt High School. Aimed at preventing juvenile delinquency and youth violence, the program will have a number of aspects, according to City sources.

The proposal, which has been in the city's planning "pipeline" since late spring, says that the officer will be "highly visible" and will develop an "amicable relationship between law enforcement, faculty, staff and students." In addition, the plan calls for the School Resource Officer to "be responsive to surrounding residential neighborhoods and businesses adjacent to school property" which from time to time may experience "student overflow or loitering."

While trying to identify what has been called "pre-delinquent" behavior, the plan also calls for the SRO to handle any calls coming from the school.

The draft of the SRO program

contains the idea that the SRO, by maintaining a constant presence, will be able to identify contributing factors that may have led to an incident. The city's program statement says that it is also hoped that the SRO - acting as adjunct faculty and presenting crime preventing information - can help students, parents and educators better understand the role of law enforcement.

The law says that the SRO, who will periodically patrol the school, will identify pre-delinquent groups or individuals, attend faculty, school activities and PTA meetings. The SRO will remain a city employee under the supervision of the Chief of Police.

Council May Ban Handbills Opposes Liquor License

At its July 11 regular meeting, the Greenbelt City Council went on record against the liquor board granting a liquor license to the Greenbelt Variety Store in Roosevelt Center. Council's contention in opposing the license is that it is not needed for public accommodation, traffic concerns and that it will change the nature of the business, which Councilmember Edward Putens said is frequented by "a lot of kids."

No one from the variety store attended the meeting.

Handbill Ban

At its next meeting on August 8, the council is expected to take final action on legislation to regulate the distribution of commercial handbills on private property. The legislation introduced at the July 11 council meeting provides for a \$400 fine for violations. Council also heard reports on a possible service exchange for seniors.

Property owners would have to post signs such as "no trespassing" or "no peddlers or agents" in order for the ordinance to apply. For posted properties the ordinance prohibits the throwing, depositing or distribution of commercial handbills.

According to City Solicitor Robert Manzi the bill is intended to address citizen concerns about materials left when property owners are away. There is concern that the handbills alert thieves to the owner's absence. In addition to handbills left near doorways Manzi said that the ordinance would prohibit the leaving of handbills on cars in posted parking lots.

The law would not ban all materials however. It specifically exempts mail and newspapers. At the request of Putens a specific exemption will be added for

political information left by doorknocking candidates.

In addition to the specified exemptions, Manzi said that the law would not apply to materials left by public utilities such as Pepco and possibly also the cable television company.

Service Exchange

Patricia Unger, vice president of the Senior Citizens Advisory Committee, reported to council on the group's status in investigating the establishment of a time/dollar exchange program. Under this program, patterned after programs such as babysitting exchanges, participants would receive time credits for providing services to others. Those credits entitle the participant to receive service from others. The credits can be banked for future use or donated to others.

An important principle for the committee, said Unger is that it must be an intergenerational program. This conflicts with the rules of an umbrella group, the Cooperative Caring Network, that the committee is considering working with. That organization restricts participation to those over 60. The SCAC is working to see if the rules can be negotiated to better meet Greenbelt's needs.

Two Women Abducted At Area Shopping Centers

Two nighttime abductions, apparently unrelated, took place in Greenbelt shopping center parking lots the week of July 10, according to Greenbelt Police. In the most recent incident, the victim was also sexually assaulted and robbed.

In both incidents, the female victims were driven in their cars to unknown locations in the District and Maryland. Both victims had left the store, and were about to enter their vehicles when they were approached from behind, forced to give up their keys, and forced into their vehicles.

"At this point we don't know if they're connected," said police spokesman Officer George Mathews. "But we're looking into it."

The most recent incident took place about 12:15 a.m. at Beltway Plaza in the parking lot in

front of Giant Food on Thursday, July 14. The victim was confronted by three men, one with a gun. She was forced to withdraw money from ATM machine, at various locations, and sexually assaulted. After about 12 hours, the victim was able to get into her car and flee while the suspects' attention was diverted.

In the previous incident, which began in front of the Safeway at Greenway Center at around 9 p.m. on July 10, the woman was accosted by two men, who See ABDUCTIONS, pg. 2, col. 2

Public Hearing

The Greenbelt City Council has scheduled a public hearing on August 8 on the request of the Greenbelt Bicycle Coalition that the capital improvement project to provide bicycle lanes on Crescent Road be moved from 1995-1996 to the current construction season.

As the people of Greenbelt consider this issue we should consider that autos are the single largest source of U.S. air pollution. Short trips—those that are most bikable—emit up to three times more pollution per mile than long trips. When substituted for shorter trips the bicycle eliminates 3.6 pounds of auto pollutants per mile. More bicycle use means less benzene, cyanide, lead, carbon monoxide, CFCs, sulfates and ozone in the air we breathe.

implied they had a gun. She was released unharmed at the point from which she was abducted after about an hour and 40 minutes. The two suspects then fled on foot toward Greenbelt Road.

Safety Tips

Mathews, who, periodically assists local crime watch programs had some suggestions for residents with security concerns.

He emphasized that people should always be aware of their surroundings, and should not proceed any further if they noted suspicious activities. "If you have some concerns, get an employee to escort you to your vehicle," he said. "Don't get yourself into a situation that you can't get out of." He also urged people not to hesitate to call police. "You're not only helping yourself, you're helping your fellow citizens," he said.

"It's just a good idea to work crime prevention habits into your daily routine," he added.

Managers at both Safeway and Giant said they could accommodate for escort assistance. In addition, Beltway Plaza Marketing Director Judith Lee said the mall's security personnel could provide such service to shoppers. "At any time on any given day, there are six or seven guards on duty," she said.

Greenbelt Police officers have also been providing private security and traffic management assistance to the Beltway Plaza Giant which is the largest in Giant Food's chain and one of the largest supermarkets on the East Coast. It opened April 7, 1993 at a cost of about \$6 million.

Suspects Sought

Greenbelt Police supplied composite sketches and descriptions of suspects wanted in connection with the abduction of two women in separate incidents July 10 and 14. Anyone with information should contact Det. Croisette (301-507-6530) of the Criminal Investigations Unit. Informants need not give their names and may qualify for a reward of up to \$500.

Suspects in the July 10 incident both described as black males in their 30s wearing dark-colored T-shirts and dark pants. Both may also have been wearing gloves. One suspect is described as 5'10", about 170 lbs., the other as 5'7". No sketches are available at this time.

Man Captured After Standoff

County police captured a man who held police at bay for over three hours after threatening nearby construction workers with a rifle and firing two shots from a condominium window, according to Greenbelt Police, who were first to arrive on the scene and provided assistance. The incident took place Monday, July 18 in the 8000 block of Mandan Road in Greenbelt East.

The suspect, Russell William Burton, 42, of Upper Marlboro, is being held at Prince Georges General Hospital for psychiatric evaluation. No charges have been filed at this time.

No one was injured in the incident.

Police said that shortly before 8 a.m., they were told that a man had pointed a bolt-action rifle towards construction workers from the window. When officers arrived on the scene a few minutes later, they heard a single shot. Police immediately moved to the rear of the building and then heard a second shot. They then sealed off the area and began moving pedestrians and commuters out of harm's way.

The Prince Georges County Conflict Management (formerly called "SWAT") team, which is specially trained to handle such situations, was summoned and arrived shortly thereafter. A stalemate ensued. The suspect was subdued by the county team at 11:24 a.m. after being hit by a rubber bullet, said Greenbelt Police spokesman Officer George Mathews.

After the suspect was apprehended, said Mathews, two bolt-action rifles and a shotgun were found in the apartment.

Police were unable to provide information about what precipitated the incident. Mathews said that police had been called to the same apartment several days earlier after a disturbance was reported, but no arrests were made. He added that the construction workers had been breaking up concrete using air hammers, a

Wetter Hit and Run Driver Sentenced

On July 14, Cary Paul Wade was sentenced to five years in prison for the hit and run accident that caused the death of 82 year old Tillie Wetter as she was crossing Ridge Road in front of the Mishkan Torah synagogue on February 5, 1993. Wade, age 40, resided at 10-C Plateau.

A Prince Georges County jury on May 27, 1994 found Wade "guilty of homicide by motor vehicle while intoxicated." At the time of the verdict Judge William B. Spellbring revoked Wade's bond and incarcerated him in the Prince Georges County detention center.


District Court Judge Patrice Lewis on July 19 also found Wade in violation of probation for driving while intoxicated. This incident occurred in Old Greenbelt prior to the fatal accident. The case was heard in the District on July 19. Judge Lewis sentenced Wade to an additional year in prison to run consecutively to the five year sentence of Judge Spellbring.

The defense will have 30 days from the date of sentencing to appeal. The defense attorney is Leonard Stamm. Assistant States Attorney Jim Papirmeister prosecuted the case.

process which generates intensely loud noise.

Mathews said a large number of police personnel from both departments were on the scene, including Greenbelt Police Chief James Craze and a number of upper-echelon county police officers, to keep people away and to provide for unforeseen developments. The Conflict Management team, which had 10 or 12 officers involved, used a police armored vehicle to assist in the capture, he said.

A situation like that is "very unstable," said Mathews, adding that it was "extremely fortunate" that the situation was resolved without casualties.

Goldberg-Strassler Honored for Service

Long-time Greenbelt resident Robert Goldberg-Strassler was honored with the President's Award on June 26 at Mishkan Torah Synagogue where he has been an active member for over a decade. He was recognized for his devotion and service not only to the local synagogue, but also to the larger Jewish community and to Greenbelt and Prince Georges County.

In presenting the award, Mishkan Torah president Gary Kohn noted that Goldberg-Strassler is a selfless individual, always preferring to operate in the background and avoiding either publicity or recognition. Yet he has always taken the initiative to implement new ideas and was usually among the first to volunteer his services when others declined. His attention to the needy has been the most notable of his accomplishments. Each year he sponsors a sandwich-making session with the Mishkan Torah children for a local homeless shelter; He has also organized a "baby shower" for a local shelter.

Other projects have been creation of the Cafe Tzedakah, an informal night club for entertainers who donate their proceeds to a charity of their choice; a collection for the Holocaust Museum, which resulted in a donation of nearly \$1,500 toward the new museum's construction; and arrangements to bring 100 children from Harlem to the museum.

Goldberg-Strassler has been active in organizing the Prince Georges County Jewish Festival, as well as a founder of the county's Jewish Council. His activism extends to the public school system as well, where he was involved with implementing a Jewish curriculum. He has also found time to coach in the Greenbelt Boys and Girls Club t-ball and coach-pitch leagues.

The award to Goldberg-Strassler was held in conjunction with Mishkan Torah's Volunteer Recognition Night, where 150 people were honored for their service to the synagogue over the past year.

In addition, the membership installed its slate of officers and committee chairs for the new year. The new officers for the 1994-95 year are: president, Gary Kohn; executive vice president, Robert Goldberg-Strassler; vice president-programs, Alan Schultz; financial secretary, Robert Silverman; treasurer, Ralph Mollerick; corresponding secretary, Sheila Lemus and recording secretary, Susan Ponemon.

A Doll-Making Project During World War II

The current exhibit at the Greenbelt Museum includes a special display depicting the World War II doll-making activities of a group of American women in Montevideo, Uruguay.

During the war years, they found themselves far from home and stateside "homefront" war efforts. These women, among whom was my mother, were wives of men working for American companies or business interests in Uruguay. My father was there to establish an American-Uruguayan library open to the public, which eventually became a U.S. Information Agency library.

Port-of-Call

Uruguay was officially neutral during the war, but U.S. sailors and merchant marines were a familiar sight on the streets of Montevideo, a regular port-of-call for ships in the South Atlantic. A USO canteen, run by American women, was a popular place for them to gather and drink . . . milk, that is. Few ports they stopped in had pasteurized milk that was safe to drink. They drank lots of it, making up for weeks and months at sea with only canned or powdered milk. The Uruguayans were very amused.

The war came close whenever there was news of a ship torpedoed and sunk at sea. Each time, the canteen workers feared that they had lost some of their milk-drinking guests.

Projects

Even before the war, the American community, primarily through the American Women's Club, engaged in philanthropic projects for the needy among the local population. Popular and successful were collections of new clothing and toys for children, which were distributed by the Uruguayan Red Cross.

My mother participated by contributing two cloth dolls that she had designed, made and dressed. The dolls were so well received that she was asked to lead a group of interested American women to produce similar dolls in quantity. This was the beginning of the doll-making project. She used a handmade cloth doll of mine as a pattern,

a baby gift from friends. She made the pattern from brown paper and cut out doll bodies, heads, arms and legs from heavy unbleached muslin. Seated at a borrowed treadle sewing machine, she sewed the pieces together, ready for stuffing.

Doll-making

The doll-making group, never more than 10 or 12, met monthly in the homes of members during the fall and winter seasons between 1943 and 1945. The pre-sewn bodies were stuffed with sheep's wool, a locally available product in plentiful supply. My mother's special task was to stuff all the heads. Everyone agreed that Dorothy was the only one who could pack them tight enough so the heads wouldn't be lumpy or flop over on skinny necks. She also drew all the faces with colored pencils and pastel chalk. At the end of each get-together, dolls that were ready were distributed to the women to take home to dress, as their imagination, skill, and available dress scraps permitted.

And such a transformation! Dolls came back in unbelievably well-tailored suits and blouses, evening gowns, Sunday outfits, hats, gloves, muffs and more. In this way, the women turned out hundreds of beautifully dressed dolls.

Some of the dolls were sent back to the United States, to Walter Reed Hospital in Washington, D.C., so convalescing G.I.'s could have dolls as gifts for their visiting children.

The display at the museum, prepared and loaned by Dorothy Gropp of Crescent Road, includes many of the items mentioned: an unfinished doll, the original pattern, the proto-type which served as a model, clothing, photographs of the finished dolls, and the group at work.

The popular exhibit of dolls of the 1930's and 1940's will remain open through September. The museum is located at 10-B Crescent Road.

How the program should be funded has not yet been determined. The committee is considering three main options—joining the Cooperative Caring Network, setting up a separate Greenbelt organization or finding other sources.

Community Center Inspector

Council awarded a contract for inspection work at the new community center to Professional Consulting Services, Inc. The city staff had recommended hiring Greenman-Pedersen, Inc. for a flat-fee plus expenses. However, led by Councilmember Rodney Roberts, council opted for the hourly fee proposed by the other firm.

Fruchtman was willing to renegotiate the contract conditions that have drawn the fire of some co-op members. In addition to being theater manager, Fruchtman was being paid as assistant general manager of GCS.

Over 50 members turned out for the meeting. Six remuneration plans were proposed, discussed and referred to management for further study. Management's recommendation was to go to the board who would then submit it to the membership for approval.

However, prior to the special meeting Fruchtman submitted his resignation as assistant manager, thereby reducing his pay check.

GEAC Opposes "All 'n One" BICYCLIST HIT BY CAR

The summer provides no time off for the Greenbelt East Advisory Council (GEAC) as it proceeds to meet on various matters affecting the community. The proposed "All 'n One" restaurant to be operated by Pepsi Corporation (Pepsico) at the site of the former Kangaroo Katie's in Greenway Center was the primary topic of discussion at the July 7 meeting of GEAC.

Two representatives of the shopping center presented thorough information on the planned restaurant and the impact to the community should the zoning be approved and liquor license transferred. Pepsico's "All 'n One" restaurant would contain Taco Bell, Kentucky Fried Chicken and Pizza Hut restaurants, with sit-down and drive-through service. Issues which the shopping center representatives and GEAC board members discussed included the increased traffic congestion that may result, the proximity to Eleanor Roosevelt High School and the increased foot traffic from the school, as well as the increased waste disposal needs of the establishment and ensuing litter problem.

Petitions

The greatest issue is the serving of alcohol in the fast-food setting. "Fast food and liquor simply don't mix," commented Greenbelt Councilmember Edward V.J. Putens. Petitions are now being circulated throughout Greenbelt regarding the serving of alcoholic beverages at the "All 'n One." The shopping center representatives and GEAC members appeared in consensus in making every effort to impact the Prince Georges County Liquor Board decision at their upcoming hearing on August 25 at 10 a.m. at the County Building in Hyattsville.

Concerns over the alcohol license result from the original restaurant property covenant that includes a stipulation regarding the type of restaurant that can be located on the site, a "sit-down" restaurant serving alcohol. One of the shopping center representatives suggested that the covenant implies that it be a "quality" restaurant. Several other possible restaurants have been mentioned as alternatives to the proposed "All 'n One," including Ruby Tuesday's, California Pizza Kitchen and Chevy's. "All of these—and probably more—would be suitable alternatives avoiding the nagging issues that remain regarding alcohol, traffic and waste disposal and their impact on the community," said one of the representatives from Combined Properties, owner of Greenway Shopping Center.

GEAC Treasurer Charlene MacAdams proposed that GEAC write a letter to the Pepsico CEO opposing the "All 'n One" and strongly opposing the mix of alcohol and fast food. GEAC passed the proposal and the letter will be prepared and mailed as soon as possible. GEAC member Sheldon Goldberg expressed some concern about the actual impact of the site plan and the figures provided by Combined Properties on increased traffic flow. "I just don't see how they (Combined Properties) can estimate a three to six times increase in traffic from one restaurant," questioned Goldberg.

Other items on the agenda at the July 7 meeting included discussion of a letter received by the city's Public Works Director regarding a possible city recycling center in Greenbelt East. GEAC President Tim Sechrist summed up the committee's remarks, "Since a recycling center in Greenbelt East would be a duplication of the city's efforts

(referring to the recycling center in Buddy Attick Park, such a facility is unnecessary."

Greenbrook Lake

City Councilmembers Putens and Thomas X. White reported that the next round of approvals is expected for Greenbrook Lake. City officials and county Department of Natural Resources officials met with County Executive Parris Glendening recently to discuss the submitted design. "The main purpose of the meeting was to preserve funding for the project" said White. GEAC members hope that after the permit is granted, the second parcel of land in the original plan will be included.

Both Putens and White suggested that GEAC urge Greenbelt East residents to apply for vacancies in various city advisory committees.

GEAC will investigate the continued concerns over cars speeding on certain non-city roads, as well as the use of basketball courts by non-residents.

Recycling Corner

No caps, please!! Whether it's glass bottles or plastic jugs, leaving the caps on the container is a problem when recycling "post-consumer" material. Why? The plastic caps are made of a different plastic resin—generally PVC (No. 3) or PP (No. 5) which are incompatible for recycling. When recycling plastic containers, remember only certain containers are included in the recycling program. Specifically, milk/water jugs, soda bottles, and liquid laundry detergent. Feel free to flatten milk/water jugs.

Sorry, no motor oil bottles, no microwave trays, no styrofoam, no plastic toys or kitchen utensils are recyclable at this time. Other plastic containers coded No. 1 or No. 2 that are not "bottles" such as yogurt, margarine or ice cream tubs are also not recyclable. On Tuesday, June 28, at about 3:40 p.m., the bicycle that Jacob Warner was riding was struck by a car as Warner was attempting to cross Kenilworth Avenue (MD Route 201) at Ivy Lane. Neither Warner nor Luther Motter, the driver of the car, were charged in the collision. Warner had been returning to his home in Greenbelt from a 30 mile ride which he has been taking every other day for the past three years. On his return from Lake Artemesia he rides along Cherrywood Lane and then turns right (southbound) onto Kenilworth Avenue. Just prior to the accident Warner had traveled south on Kenilworth Avenue and was waiting at the right hand curb near Ivy Lane. He was attempting to reach the sidewalk that goes behind the Lakeside North apartments.

The car, a Toyota Corolla, struck the rear wheel of Warner's bicycle (a Century 10-speed), causing him, according to one witness, to be thrown in the air and spun around before landing on the pavement. Warner received several cuts and bruises, but was not seriously injured. He credits his helmet with saving his life. According to Warner Cpl. Carl Schinner, Greenbelt Police, arrived quickly on the scene, and an ambulance soon after.

Several witnesses stopped to assist Warner after the accident. Among them were Gene Harley and Michelle Royal. They had, perhaps, the best view of the accident as they were waiting to turn left onto Ivy Lane from northbound Kenilworth Avenue. Harley performed first aid on Warner while Royal called the police with her cellular phone. Witnesses described traffic as being heavy and moving at about 40 MPH, which is within the posted speed limit. Warner does not understand how he could have not seen the car that hit him. The section of Kenilworth Avenue north of Ivy Lane curves which, according to Motter, creates a "dangerous blind spot." None of the witnesses faulted either Warner or Motter with the accident.

Man Hangs Self At Police Station

A man hanged himself Tuesday afternoon shortly after being detained in a holding cell at the Greenbelt Police Department building, according to Greenbelt Police. Police said he had been arrested with a companion after the pickup truck in which they had been driving was found to contain suspected "crack" cocaine.

The man's name is being withheld pending notification of next of kin. Police said he was a 42-year-old white male.

Greenbelt Police Department spokesman Officer George Matthews said that nothing unusual had been observed about the suspect's behavior prior to the incident. He said the man apparently had employed strips torn from his T-shirt.

The suspect was driving a vehicle stopped by police for a registration violation at Greenbelt Rd. and 63rd Ave. at about 1:30 that day. He fled the scene on foot, police said, and was apprehended after a short foot chase across four lanes of traffic on Greenbelt Rd. The other occupant of the vehicle was detained without incident.

Police said a computer check revealed that the registration plates were stolen, and a quantity of suspected "crack" cocaine was found inside the car.

After being placed under arrest, the suspects were transported to the Greenbelt City Police Department building on Crescent Rd. Police said they were then thoroughly searched, fingerprinted, and photographed and placed into separate cells.

About 20 minutes later, police said, an officer checking on the prisoners discovered that the suspect had hanged himself in his cell. He was taken down immediately and the Fire Department Emergency Services ambulance was summoned. He was pronounced dead at the scene, said police.

Police said the incident is under investigation.

Youths Sentenced For Armed Robbery

According to the Greenbelt Police, one of the two suspects arrested in an armed robbery which occurred in the 7700 block of Hanover Pkwy. last February 2 was found guilty by Judge Vincent Femia on Tuesday, July 12, on three separate charges: (1) robbery with a deadly weapon; (2) use of a handgun in the commission of a crime; and (3) defacing a serial number on a handgun.

Nonresident Winston Nathaniel Lark was tried as an adult and will face sentencing before Judge Femia next month.

His co-defendant, nonresident Dante Marshall, was also tried as an adult and pled guilty; he received a three year sentence in jail.

Local Man Charged In Domestic Dispute

According to the Greenbelt Police, 29-year-old Rodney Seville Robinson was arrested and charged with two counts of battery, theft under \$300, and possession of a controlled dangerous substance (CDS) with intent to distribute on Saturday, July 9. Officers responded to a report of a domestic dispute at 5921 Cherrywood Terr. around 7 p.m. and found a woman standing outside the building who said that her husband had become very agitated during an argument and had started hitting her and her son. She also said that there was a gun in the apartment. Officers then established communication with the man, and after some time, the man did open the door. He was then arrested. Police subsequently found the gun, which turned out to be stolen, and several baggies of crack cocaine. The man appeared before a District Court Commissioner and was held on \$35,000 bond pending trial.

Greenbelt police said Wednesday that the man who died in a Greenbelt Police Department holding cell Tuesday afternoon was named Stephen Edwin Cantrell, of no fixed address. They gave his date of birth as December 6, 1951.

The victim complied. The robber is described as black, 18-25 years old, 5'4", about 165 lbs., black hair, wearing a dark blue or black ski mask, a white T shirt with blue writing on the front, gray sweatpants and white sneakers.

As a woman was driving east on Greenbelt Rd. around 2:30 p.m. on Thursday, July 14, a Ford Bronco struck her vehicle lightly on the passenger side just east of Hanover Pkwy. The Bronco then pulled alongside her, passed her, and turned left onto Mandan Rd. The driver of the Bronco is described as male, Hispanic, 17-18 years old, with dark brown hair. The Bronco is described as full size, (tan over brown, and with a spare tire mounted on the rear and covered with a black cover with "BRONCO" and a horse on it.

Summer is Tick Time

Ticks are most active in summer. Seeking a blood meal they often crawl up on grasses trying to hitch-hike and feed on passing humans, pets or other animals.

Two types of ticks are found in the Greenbelt area. Both transmit disease causing organisms to humans. The dog or wood tick transmits Rickettsia which causes Rocky Mountain Spotted Fever. The deer tick, newer to the area, transmits Spirochete bacteria which cause Lyme disease in humans and pets.

Persons frequenting grassy and wooded areas should protect themselves by wearing a hat, long-sleeved shirt, and long pants with their socks pulled over the pants. They should spray insect repellent on their clothing to repel ticks. Upon return from these areas especially deer trails, children, adults and pets should be closely inspected for ticks. Unattached ticks should be killed. Either type of tick, if attached, should be carefully removed and saved in a small bottle of alcohol for later identification in the event disease symptoms occur. To remove ticks always use small pointed tweezers when grasping the tick at the head. Apply gentle pressure slowly so that the head parts come out without crushing the tick and forcing tick body fluids into the victim. After tick removal the area should be washed and disinfected. The adult deer tick is about one-third the size of the dog tick. Its nymphal stage is no larger than a pin head and can easily be overlooked. Major early symptoms of both diseases may be high fevers, severe headache, muscle aches and weakness, or joint pains. Red rashes may or may not appear in three to five days after infection. Early treatment for both diseases by doctor prescribed antibiotics is usually effective. Later untreated Lyme disease symptoms include complications of the heart, joints and dementia and permanent paralysis. Some symptoms may mimic a variety of diseases such as multiple sclerosis, arthritis, and Alzheimer's disease. Anyone who suspects infection should contact a physician.

Editors Note:

John Taylor was bitten by a deer tick near the Northway ballfields and probably had lyme disease. He found the problem quickly and was treated. He's particularly concerned that children of parents who play ball at Northway roam the area of the woods edge. Parents should check their children carefully.

Concern Expressed on Cable TV Corporation Bankruptcy

The bankruptcy of Maryland Cable Corporation (MCC), the owner of the northern Prince Georges County cable system, has generated uneasiness among its 20 franchising authorities. The county (representing unincorporated communities) and municipalities in the northern area want to respond with one voice to MCC's proposal to transfer ownership of the system, which is operated by Multivision.

Deputy City Manager Michael June 7 meeting with the county, McLaughlin reported that, at a the law firm hired jointly by the

county and various municipalities—Miller, Canfield, Paddock and Stone (Miller et al)—said their review of the transfer proposal raised concerns. According to McLaughlin, they were disturbed that there would be no resources "for the new owner to upgrade or rebuild the existing cable system" and that the debt levels proposed in the transfer "are so great after the first five years that the system will likely be sold again prior to that

point."

McLaughlin also noted that Miller et al recommended that "issues concerning cable television that would normally be part of a discussion during refranchising should be raised now." They observed: "With the refranchising following so closely to this proposed transfer process, issues not raised now may not be allowed during refranchising." Greenbelt's franchise is up for renewal in 1997.

Joint Meeting

David Wilson, vice president and regional manager of Multivision, told the News Review that concerns raised by Miller et al will be addressed on July 19 at a joint meeting between representatives of the involved parties and Multivision representatives. McLaughlin is a member of the negotiating team.

Wilson asserted, "At that time the record will be set straight." He noted that there have been improvements to the system at the Lanham headend, which sends signals to three hubs — Hyattsville, Beltsville and Bowie. Some coaxial trunk cable has been replaced with fiber optics, he said, which eliminates electronics along those routes and increases channel capacity.

Fiber Optics

Wilson also pointed out that fiber optics are currently being installed along Route 1 from the District of Columbia Line to

Howard County. This will "enable increased signal reliability to customers along that corridor," he added.

According to a March 10 Multivision press release, Maryland Cable Corp., together with its parent Maryland Cable Holdings Corp., "filed a prepackaged plan of reorganization with the U.S. Bankruptcy Court for the Southern District of New York, pursuant to Chapter 11, U.S. Code."

The release noted that MCC and the Water Street Fund, "managed by the investment banking firm of Goldman Sachs agreed that the bondholders would create and own a 'New Company' called Maryland Cable Partners, LP." However, to accomplish the restructuring out of court, the company needed the bank group and remaining bondholders to agree to the reorganization plan. (The system was bought from Prime Cable in November 1980 with a loan from Citibank, equity from MCC and Water Street Funds bonds.)

Since MCC did not receive approval from the bank group, it filed a "prepackaged" bankruptcy on March 10. On May 2 the Bankruptcy Court confirmed MCC's plan of reorganization, currently anticipated to be completed no later than September 30. However, approval of the transfer by the franchise authorities must be accomplished by the first week of September.
