Council Considers \$3.5 Million Bond Issue for Major Projects

At the November city council election the voters will be asked whether the city should take on millions of dollars of bond debt to pay for several large city projects. That was the consensus of the July 18 council worksession on Capital Projects. There were differences among councilmembers as to which projects to put before the voters.

The council will discuss the issue further at its August 13 meeting. Council must decide soon which projects to include and for how much if the bond referendum question is to appear on the November ballot.

The projects most councilmembers wanted to see funded by a bond issue were: expansion of the public works department's offices and workspace, renovation and expansion of the Springhill Lake Recreation Center, road improvements of some type in Greenbelt East, and renovation of the Greenbelt Theater. The size of the bond debt mentioned was \$3.5 million to \$4 million.

Discussion of all capital projects (big ticket items that fall

outside the regular departmental annual budget) was supposed to take place at the July 18 worksession. But after council listened to representatives from the Greenbelt Dog Park Association, and Skateboards Wheels and Trucks, they spent the rest of the

meeting in an intense, freewheeling discussion of the bond issue. The other capital projects will be discussed at a worksession on August 20.

On whether even to incur the debt of a bond issue, Councilmember Rodney Roberts said he had no problem with putting the question to the citizens and letting them decide, but he would rather see the city's current debt paid off. City Manager Michael McLaughlin said the current schedule is for the city to be

debt free in 2006. Debt free means an opportunity to really lower the tax rate, he said. A bond issue would extend the city's debt for 10, 15, or 20 years - depending on the details council decides upon.

With interest rates dropping, the city has an opportunity to get some projects done, said Councilmember Edward Putens. City Treasurer Jeff Williams said he had just called up the Bank of America to get an idea of the interest rates and was quoted 3.9 to 4.2 percent.

Councilmember Alan Turnbull also expressed unease with a bond issue. He said he thought right now the city had problems every year meeting its budget. He said he would prefer having \$200,000 to \$300,000 in the budget every year for big projects.

The other two members of council said they could see the need for bond referendum to finance large city projects.

Public Works

All the councilmembers were for funding the expansion and

Bank of America to Close

Letters have gone to Roosevelt Center Bank of America customers announcing that the bank will close on November 16 at 2 p.m., and that bank services will be relocated to the Beltway Plaza Bank of America.

Corporate Affairs spokesperson Terri Bolling told the News Review that the bank is being closed for low volume of business and because Greenbelt has three other Bank of America branches within a radius of about one mile—at Beltway Plaza, Ora Glen Drive, and Cipriano Square.

Bolling said corporate managers considering a bank closure take into consideration, in addition to proximity, factors of market demographics, the physical condition of a bank and whether its facilities and technology can be updated. Those willing to do

online banking, she said, may do so at www.bankofamerica.com.

In response

Senior citizens plan to protest the closing of the only bank to which they can and do walk. They have drawn up a petition and will be in front of the bank this week soliciting signatures.

"Irate Greenbelters are vehemently protesting the closing," said Emory Harman, one of the protest leaders. Signs and posters will be carried in front of the bank and around the Roosevelt Center, he said. "Senior citizens are shocked and apprehensive as they have done business with this branch for over 50 years," Harman explained.

The petition protests the closing, asks that plans for the closing be stopped, and requests a response.

Filing Deadline for Council Candidates Is September 24

On Tuesday, November 6, Greenbelt citizens will elect the five members of the City Council who will represent them for the next two years. Greenbelt residents who want to run for City Council, sign a petition for someone to run for council, or vote in the election must be registered to vote in Prince George's County. Since universal voter registration began in Greenbelt in 1991, the city has not maintained a separate voter registration list.

Candidacy for Council

Any qualified voter of the city wishing to run for council may do so by submitting the following forms:

1. Nomination Petition - This form requires the signature of at least 50 qualified voters of the city, and must be signed by the circulator of the petition and notarized. The signatures should give the petitioner's proper name (e.g. Mary Doe or Mrs. John Doe) and address.

2. Acceptance of Nomination - This form notes that the nominee agrees to serve, if elected. It must be filed along with the nomination petition and an affidavit containing a sworn statement

providing the candidate's name, date of birth, Social Security number and resident address.

3. Financial Disclosure Statement - This form lists business entities and real estate interests held by the nominee and family, and sources of specified income or debt. The statement covers the period January 1, 2000 through December 31, 2000. Candidates who have had changes in their financial status are required to file a supplemental report for the period of January 1 through June 30, 2001. The financial disclosure statement must also be notarized.

The deadline for filing to be a candidate in the November 6 regular election is Monday, September 24 at 5 p.m.

The City Clerk verifies that nomination petitions meet the requirement of the city charter. A drawing will be held by the Board of Elections in the City Offices on Monday, September 24 at 7:30 p.m. to determine the order in which names shall be placed on the ballot. This meeting is open to the public; candidates, their families, supporters, and interested citizens may attend to witness the draw.

Candidates must appoint a treasurer. Candidates are also required to file a notarized interim

report of campaign contributions and expenditures no later than noon, October 22. A final campaign contribution and expenditure report must be filed no later than 5 p.m. Monday, November 12. These reports shall list the name, address, and amount contributed of every contributor, and name, address and amount of every expense, other than the candidate or a member of his or her family, who has contributed more than \$25 in furtherance of the candidate's nomination and election.

Voters who will be unable to appear at their polling place on November 6 by reason of illness, religious beliefs or absence from the city may vote by absentee ballots. The first day to apply and vote by absentee ballot will be Wednesday, October 17. (Please watch for city ad.)

Election of Council

The five candidates each receiving at least 40 percent of the total number of votes cast and the highest number of votes cast will be elected. If fewer than five candidates receive at least 40 percent of votes cast, a runoff election

SHL, Rest of City Could Be in Different Districts

In terms of redistricting, one thing is clear: the Greenbelt City Council favors keeping all of Greenbelt's current voting precincts — 21-03, 21-06, 21-08, and 21-13 — in the same districts for state and county elections.

Councilmanic Districts

At its July 30 worksession, the mayor and councilmembers (minus Alan Turnbull) heard from David Moran, assistant to the city manager, that the Prince George's County Commission on Redistricting has held a series of public meetings and is now developing a redistricting plan.

Using 2000 Census data, the commission is charged with reorganizing the districts so that each one will have a target of 89,057 persons, plus or minus five percent. With those figures in mind, Districts 2 and 5 must gain population, and Districts 4 (that's us), 6 and 9 must lose population.

So far, the commission has produced two draft plans, one authored by Chairman Sam Dean and one by David Merkwowitz. Dean's plan would put all of Greenbelt's voting precincts as well as 21-09 (Westchester Park) in District 4, and would move 21-10 (Metro Station and West

Hollywood) to District 1. Merkwowitz's plan would keep all of Greenbelt's voting precincts, as well as 21-09 and 21-10, in District 4.

Two more meetings are scheduled for August 22 and August 28, both at 7 p.m. in the County Administration Building, Upper Marlboro. The commission must submit its final plan to the county council by September 11. At those meetings it is expected that at least three more draft plans from other commission members will be submitted.

Legislative Districts

As to legislative redistricting, the Governor's Redistricting Advisory Committee is holding a

Editorial

A Job Well Done

Greenbelt owes a great debt to the city's Department of Planning and Community Development and to the superb staff work of its director, Celia Craze, and her assistant, Terri Hruby. Between the two of them, they have met the demands of an exceptionally heavy workload with the highest levels of professionalism. They have attended countless hours of meetings—with developers, county planners, and representatives of the Goddard Space Flight Center and the State Highway Administration. In addition, during the same period they have provided guidance to the city council in numerous council meetings and work sessions, many lasting late into the night. As Craze herself described it, "This has been the most intense period of time in all my experience in Greenbelt."

Particularly impressive have been the comprehensive reports and analyses the planning staff has prepared, both orally and in written form, to bolster the city's positions concerning two concurrent processes regarding the same piece of property, the A. H. Smith tract and the adjacent Metro site. The Sector Plan/Sectional Map Amendment (SMA) process, ongoing for several years and now the subject of three new amendments opposed by the city council, is to be formally adopted by the Prince George's County Council on September 17. During that same time period, the city's staff has had to scrutinize proposals by the developers of Greenbelt Station, both a conceptual site plan and a preliminary plan of subdivision, to develop the city's position on both proposals before the Planning Department. To facilitate these reviews, Greenbelt's planning staff engaged three specialized experts as consultants on transportation, environment, and economic projections. In the words of Mayor Judith Davis, these three—Bruce Collins of the RBA Group, Mark Burchick of Environmental Systems Analysis, Inc., and Sarah Woodworth of ZHA, Inc.—"did us proud." Throughout the trajectory of both processes (during which there have been several successive transformations), the city staff, together with these consultants, have thought concretely about how each proposal would affect the quality of life of the citizens of Greenbelt. Besides Craze and Hruby, two summer interns assigned to the Planning Department, Kristen Jalo and Gabrielle Benjamin, have helped in the gathering and assembling of necessary data. They could have had no assignment more challenging, nor mentors more professional.

renovation of the offices and work area of the public works department by a bond issue. Roberts said he saw it as only one of two projects worth doing by bond. Public Works is a given, said Putens. Councilmembers Thomas White and Roberts were not so sure. White called it an unexciting project and Roberts remarked that it is not a project at the forefront of most people's minds. But Putens said he did not think public works was a hard project to sell. The reputation of the department stands on its own, he said and it is well known the department has antiquated working conditions.

The city's public works department offices, work buildings, and facilities are in a compound that is between Kenilworth Avenue and the parking area in Buddy Attick Lake Park. The need to expand the facilities has been known for years. For example, in the 1985 referendum that was approved in 1987, this was one of the projects mentioned as being possibly funded from the referendum.

There is \$300,000 in the fiscal year 2002 budget for doing part of this project, but if the project were funded by bond referendum, then the monies could be spent on other capital projects. Planning is mostly done for this project and preliminary designs have been approved by the city council.

It is estimated that the overall cost of renovating the public works facility is \$2 million. This includes work on the existing shop building (\$200,000 to \$220,000), an addition to the administrative building (\$410,000 to \$430,000), renovating the existing administrative building and removing the trailer (\$70,000 to \$80,000), addition to the maintenance building (\$135,000 to \$145,000), and building a new maintenance building (\$800,000 to \$1,000,000).

SHL Recreation Center

All the councilmembers also

agreed that renovation and expansion of the Springhill Lake Recreation Center was a project worth funding by bond issue. It is a small facility serving a big population, said Mayor Judith Davis.

The renovation and expansion is expected to cost \$1.5 million. It had been considered that the city would seek matching state funds for an amount of \$750,000. This year the city received approval of \$300,000 from the state.

Other Projects?

Councilmembers did not reach a consensus on other possible projects to include in a bond issue. Roberts was firm in his stance that the only two viable projects to put before the public were renovation of the public works facility and the Springhill Lake Recreation Center. White said he thought the bond issue package was lacking in balance. Providing something for the east part of the city would provide balance. He thought an overpass at Eleanor Roosevelt High School and Frankfort Drive was a worthy project, because it connects two parts of Greenbelt East.

Four of the councilmembers liked the idea of a whole package of projects of street makeover and traffic calming projects for major streets in Greenbelt East. Roberts said he felt as if council was just grabbing for projects. "When are the projects going to be done?" asked Putens. "The cheapest money is right now." White, Davis, and Turnbull supported the package for Greenbelt East.

Four of the five councilmembers suggested renovation of the Greenbelt theater as a project and thought it would give the center part of the city a project. Putting the theater on the bond issue is clouding the issue, said Roberts. Why aren't the people in there supporting it now, he asked.

There have been discussions of the city acquiring the

Greenbelt theater, located in the Roosevelt Center Mall. The preliminary estimate by city staff is that \$125,000 would be needed to do basic renovation. In a memo to council, McLaughlin suggests \$250,000 would be needed for this project.

Group Requests

Members of the Greenbelt Dog Park Association showed up in force to ask council to allocate \$15,000 for expansion of and lights for the dog park. The park could easily be doubled in size, said Director of Planning and Development Celia Craze.

Margie Whitacre, president of the group, said the park is used a lot and by people of all age groups.

White threw out the idea of a second dog park in another part of the city. And he and Putens mentioned the lake park. When big water pipes were put in, the land above the pipes was left clear and the resulting easement is a possibility, White said. Roberts said he did not like the thought of the lake park. The policy always has been that the lake park is not for use by active or organized sports. Council agreed to put dog park expansion on its list of projects to consider.

Greenbelt Police Officer John Rogers appealed to council for money to help plan a skateboard park. Council members agreed to add \$5,000 for this to their list of projects to be considered. This would cover the necessary preliminary work for a park, such as planning and estimating costs.

Rogers explained that after having to chase skateboarders out of the Roosevelt Center Mall, he decided to form a group to build a skate park, Skateboards, Wheels and Trucks. The group consists of 40 Greenbelters aged nine to 17. They are working on a plan for a temporary park—pieces that can be put up and used on a schedule.

More details will be forthcoming following the August 13 council meeting.

will be held on Tuesday, November 13. Twice as many as there are positions to be filled will be submitted to the voters. A runoff has not been necessary in more than 20 years.

Greenbelt does not have provisions for election of the mayor by the electorate. At the organizational meeting on the

Monday following the election (Monday, November 12) the newly elected council will elect the mayor and mayor pro tem. Traditionally, the new council has elected the highest vote getter to be mayor and second highest vote getter to be mayor pro tem for the ensuing two-year term.

Voter Registration

Registering to vote is the first step to qualify as a voter - whether to run for office or to vote for a candidate in the November 6 regular election. Although the county Board of Elections will handle all registrations, registration forms may be picked up during regular office hours at the Municipal Building, 25 Crescent Road, or at the Greenbelt Library on Crescent Road. Voters may also call the Board of Elections at 301-627-2814 to request a form by mail. All completed forms must be received by the Board of Elections in Upper Marlboro by 4 p.m., October 8.

Qualifications

In order to vote in Greenbelt, and to be registered with Prince George's County, one must be a citizen of the United States of America; at least 18 years of age as of November 6, 2001; domiciled within the corporate limits of the city of Greenbelt as of the date of registration; not convicted more than once of an infamous crime and not currently under a sentence imposed pursuant to a conviction of an infamous crime (direct questions to the election office, 301-952-3270); and not under guardianship for mental disability.

Reception/Exhibit Of Night Photos



Greenbelt Police Cleared by Jury in Lawsuit

The Greenbelt Police Department announced the August 2 disposition of a civil lawsuit. A federal court jury found in favor of five Greenbelt police officers and a former officer who is now employed by the U.S. Secret Service, who had been alleged to have violated federal and state constitutional protections of Zachary Kent Macklin, 36, of Laurel.

Macklin had claimed that Lieutenant Michael D. Craddock, Lieutenant Thomas W. Kemp, Sergeant M. Douglas Sappington, Sergeant James M. Parker, Cor-

poral Carolyn M. Breck, and former Greenbelt officer James Keller deprived him of federal and state constitutional protections by beating and falsely arresting him after a traffic altercation. The incident began in Laurel and ended in the front parking lot of the Greenbelt police station in December 1997.

Macklin claimed that his truck had been struck by another motorist, a female, while in a gas station in Laurel. Macklin became enraged and chased the woman along back roads of Laurel and Beltsville to Greenbelt at

the direction of a 911 operator whom the woman had called for help. The woman had feared for her safety due to the behavior of Macklin.

The charges that Macklin brought resulted from actions taken by the officers to intercede in the incident to find out what was happening. Macklin's behavior led to his arrest for assault when he made an aggressive move toward Corporal Breck. After hearing testimony, the jury found that the officers had acted properly and that Macklin's charges were without merit.

series of public meetings throughout the state over the summer. The Prince George's meeting will be held on September 5 at Prince George's Community College.

Senator Leo Green has indicated that if the city would like to remain in the 23rd District, that position must be made known by September 5. Districts 13B, 23 and 27A must lose population. District 22B must gain population.

Since the July 30 council worksession, it was learned that the Prince George's delegation has approved a draft redistricting plan that moves Precinct 21-08 (Springhill Lake) from the 23rd to the 21st Legislative District. According to an August 2 letter from Mayor Judith Davis, the city was not consulted about this action. Furthermore, the 23rd district delegates had specifically

requested that action be deferred since they were not present.

"The Greenbelt City Council vehemently opposes any redistricting plan which splits our city between legislative districts," stated Davis. The letter goes on to say that "Communities that understand the value of representative government and have put forth the effort to become incorporated, should not be penalized."

Metroland Report Aired

Next Monday the Greenbelt City Council will hear a report by City Solicitor Robert Manzi dealing with the Prince George's County Planning Board's July 26 hearing on Greenbelt Station. In a unanimous vote, the board approved with conditions the proposed Conceptual Site Plan for Greenbelt Station. Council is also expected to consider appealing the planning board's decision.

In her July 30 letter to the applicant, Greenbelt Metro Park LLC, Faroll Hamer, of the Maryland-National Capital Park and Planning Commission's Development Review Division, noted that the planning board's approval of the concept plan "will become final 30 calendar days after the date of the final notice July 30, 2001, unless (1) Within the 30 days, a written appeal has been filed with the District Council (County Council) by the applicant or any Person of Record in the case; or (2) Within the 30 days (or other period specified by Section 27-291), the District Council decides, on its own motion, to review the action of the Planning Board."

At the July 30 meeting of the County Council, sitting as the District Council, Councilmember Audrey Scott requested that the concept plan's approval on the "pending finality" list be removed from the agenda to enable a public hearing on the issue within the 30-day designated period. Scott represents the 4th District, including Greenbelt.

Meanwhile the Preliminary Plan of Subdivision for Greenbelt Station has been continued again to September 6. The board's staff had requested additional information regarding environmental impacts to wetlands, to wooded stream buffers and wooded wetland buffers - permanent impacts that the staff believed would have "significant detrimental effects." If staff does not receive the required information in time for the September 6 hearing, staff's recommendation for the preliminary plan will be an automatic denial. Reportedly, if this occurs, the plan could be resubmitted at a later date, but the concept plan process could not move forward.

Fundraising for the Labor Day Festival continues. The Committee will be hosting a dance at the American Legion this Friday, August 10 from 8 p.m. to 12 a.m. The Good Guys will be performing and J the DJ will be spinning tunes. Light refreshments will be provided and there will be a cash bar. Tickets will be available at the door and can also be purchased by calling Patti Brothers at 301-982-2312.

Bake sales are continuing outside of the Co-op and will be there each weekend until the Festival. Proud to Be American t-shirts are still available - in all sizes. Raffle tickets for \$200 worth of Co-op groceries are currently being sold, as well as raffle tickets for three pairs of tickets to Cal Ripken's last series at Camden Yards (the weekend of September 21). Raffle tickets and t-shirts will also be available on Friday afternoon outside the Co-op. The above items can also be purchased by calling Patti Brothers at 301-982-2312.

Fundraising activities will continue all through the Festival and will be based out of the Information Booth. Baseball and grocery raffle tickets and patriotic t-shirts will still be available for purchase - and a character cake will be raffled off each day. Orders for Gianni's pizzas will be taken, as well as orders for PartyLite candle items - and a

beautiful candle will also be raffled off.

The Labor Day Art Shows will take place at the Greenbelt Community Center. This is the 38th year for this popular event, which gives Greenbelt artists of all abilities the opportunity to acquaint our community with their work. The shows - one for adults and one for children and teens - are co-sponsored by the Greenbelt Association for the Visual Arts.

Categories for adults are oil/acrylic painting, watercolor, drawings, graphics/collage, sculpture, and crafts. Categories for children and teens are painting, drawings and prints, and three-dimensional works including sculpture.

Artwork must be submitted Friday, August 31, from 5 to 7 p.m. at the Community Center. Flyers with complete information are available at the Community Center and the Greenbelt Library.
